5	Be it enacted by the Legislature of Louisiana:
6	Section 1. The commissioner of administration, notwithstanding any other provision
7	of law to the contrary, is hereby authorized and empowered to convey, transfer, assign, lease,
8	and deliver any interest, excluding mineral rights, the state may have to the following

The commissioner of administration, on behalf of the state of Louisiana, 27 is hereby authorized to enter into such agreements, covenants, conditions, and stipulations 28 and to execute such documents as are necessary to properly effectuate any conveyance, 29 transfer, assignment, lease, or delivery of title, excluding mineral rights, to the properties 30 described in Section 1 herein, and as more specifically described in any such agreements 31 entered into and documents executed by and between the commissioner of administration 32 and Sidney J. and Sherilyn M. Cormier, in exchange of consideration proportionate to the 33 appraised value of the property. 34 Section 3. This Act shall become effective upon signature by the governor or, if not 35 signed by the governor, upon expiration of the time for bills to become law without signature 36 by the governor, as provided in Article III, Section 18 of the Constitution of Louisiana. If 37 vetoed by the governor and subsequently approved by the legislature, this Act shall become 38 effective on the day following such approval.
