HOUSE BILL NO. 639

BY REPRESENTATIVE HAZEL

ELECTIONS/BALLOTS: Specifies certain information which must be on a ballot relative to tax matters

1 AN ACT

2 To amend and reenact R.S. 18:1284(C) and 1285(A)(1), relative to tax elections called by
3 political subdivisions; to provide requirements for tax propositions; to provide
4 requirements for notice of tax elections; and to provide for related matters.

5 Be it enacted by the Legislature of Louisiana:

6 Section 1. R.S. 18:1284(C) and 1285(A)(1) are hereby amended and reenacted to
7 read as follows:

8 §1284. Resolution calling election; proposition

9 * * *

10 C. If the purpose of the election is to authorize the levy or increase of a
11 special tax, the resolution and the proposition submitted to the voters shall clearly
12 state the rate, object, and purpose for which the tax is to be levied or increased; the
13 estimated amount reasonably expected to be collected from the levy or increase of
14 the tax for one entire year at the time it is proposed; and, if it is to be limited as to
15 duration, the number of years it is to run. If the purpose of the election is to
16 authorize an increase of a tax, the resolution and the proposition shall also state the
17 rate increase.

1 §1285. Notice of election

2 A.(1) Notice of the election shall be given and shall embrace substantially

3 all matters required to be set forth in the resolution ordering the election, including

4 a list of precincts where the proposition will be voted on and an indication for each

5 precinct as to whether or not all registered voters in the precinct will be eligible to

6 vote on the proposition, unless the proposition is to be voted on parishwide. If the

7 notice is relative to the increase of a special tax, the notice shall also clearly state the

8 proposed increase in the millage rate of a property tax or percentage rate of sales tax.

9 The list of commissioners for an election called in accordance with R.S. 18:1286(A)

10 is not required to be set forth in the notice of election. It also shall state that the

11 governing authority of the political subdivision ordering the election will, in open

12 session, at the hour and place named, proceed to canvass the returns and declare the

13 result of the election.

Abstract: Provides requirements for tax elections called by political subdivisions.

Present law establishes the requirements for special tax elections called by political subdivisions.

Present law requires tax propositions submitted to the voters to contain certain information about the tax the voters will decide upon. Such required information includes the rate of the tax, the duration of the tax, and the purpose of the tax. Proposed law retains present law. Proposed law further expressly requires such propositions to state required information in a clear manner. Requires that the proposition also state the rate of any proposed increase.

Present law requires the political subdivision calling an election on tax, bond, or debt to advertise such election for a required amount of time prior to the election itself. Present law sets forth the requirements which such notice must contain. Proposed law retains present law. Proposed law further provides that if such notices are relative to increases in tax rates or millages, in addition to other requirements contained in present law, the notice must also clearly state the proposed increase in the millage rate or percentage of sales tax.
