2	To amend and reenact R.S. 56:796(A) and (B)(1), relative to the Lake Fausse Point and
3	Grand Avoille Cove Advisory Board; to provide relative to membership of the board;
4	to provide with respect to jurisdiction over Lake Dauterive; and to provide for related
5	matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 56:796(A) and (B)(1) are hereby amended and reenacted to read as
8	follows:
9	§796. Lake Fausse Point, Lake Dauterive, and Grand Avoille Cove Advisory Board
10	A. The Lake Fausse Point, Lake Dauterive, and Grand Avoille Cove
11	Advisory Board, hereafter in this Section referred to as the board, is hereby created
12	to advise the secretary on matters pertaining to the preservation of the Lake Fausse
13	Point, Lake Dauterive, and Grand Avoille Cove area and to the development of
14	recreational opportunities in the area.
15	B.(1) The commission is comprised as follows:
16	(a) The member of the Louisiana House of Representatives representing
17	House District Number 49 or his designee.
18	(b) The member of the Louisiana House of Representatives representing
19	House District Number 50 or his designee.
20	(c) The member of the Louisiana House of Representatives representing
21	House District Number 46 or his designee.
22	(c) (d) The member of the Louisiana Senate representing Senate District
23	Number 21 or his designee.

1	(a) (e) The member of the Louisiana Senate representing Senate District
2	Number 22 or his designee.
3	(e) (f) Two members of the Chitimacha Tribe appointed by the governing
4	authority of the tribe.
5	(f) (g) One member appointed by the mayor of Baldwin subject to
6	confirmation by the governing authority of Baldwin.
7	(g) (h) One member appointed by the mayor of Jeanerette subject to
8	confirmation by the governing authority of Jeanerette.
9	(h) (i) The member of the St. Mary Parish governing authority representing
10	Council District Number 1 or his designee.
1	(i) (j) The member of the Iberia Parish governing authority representing
12	Council District Number 11 or his designee.
13	(k) The member of the St. Martin Parish governing authority representing
14	Council District Number 1 or his designee.
15	(j) (l) The Eagle Point Park Committee shall appoint two of its members to
16	serve on the board.
17	(k) (m) The members of the Legislature of Louisiana referenced in
18	Subparagraphs (a) through (d) (e) of this Paragraph shall collectively appoint one
19	licensed commercial fisherman.
20	(1) (n) The members of the Legislature of Louisiana referenced in
21	Subparagraphs (a) through (d) (e) of this Subsection shall appoint one member from
22	a list of three nominations submitted by the local chapter of Ducks Unlimited.
23	(m) (o) The governing authority of the St. Mary Parish Consolidated Water
24	and Sewer District of Charenton shall appoint one of its members to serve on the
25	board.
26	(n) (p) The lieutenant governor, the secretary of the Department of Wildlife
27	and Fisheries, and the secretary of the Department of Natural Resources may each
28	designate an individual to serve as a nonvoting member of the board.

1	(q) The parish presidents for Iberia Parish, St. Martin Parish, and St. Mary
2	Parish, shall serve as ex officio nonvoting members of the board or may designate
3	a person to serve in their stead.
