APPROPRIATIONS/JUDGMENT: Appropriates funds for payment of judgment against the State of Louisiana, Office of Group Benefits, in the matter of "Capitol Anesthesia Group, P.A. v. Gus Watson"

1	AN ACT
2	To appropriate funds out of the General Fund of the state of Louisiana by Fees and Self-
3	generated Revenues of the Office of Group Benefits for Fiscal Year 2011-2012 to
4	be used to pay the consent judgment in the suit entitled "Capitol Anesthesia Group,
5	P.A. v. Gus Watson"; to provide for interest; to provide for attorney fees; to provide
6	for court costs; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. The sum of Twenty-Six Thousand One Hundred Seventy-Nine and 18/100
9	(\$26,179.18) Dollars, plus legal interest from March 18, 1998, until paid, plus attorney fees
10	in the amount of Thirty-Four Thousand Eight Hundred Seventy-Five and 75/100
11	(\$34,875.75) Dollars, plus court costs in the amount of Three Thousand Forty-One and
12	26/100 (\$3,041.26) Dollars, is hereby appropriated out of the General Fund of the state of
13	Louisiana by Fees and Self-generated Revenues of the Office of Group Benefits for Fiscal
14	Year 2011-2012 to be used to pay the consent judgment in the suit entitled "Capitol
15	Anesthesia Group, P.A. v. Gus Watson", bearing Number 20,348, Section B, on the docket
16	of the Seventh Judicial District Court, parish of Catahoula, state of Louisiana.
17	Section 2. The judgment provided for in Section 1 hereof shall be deemed to have
18	been paid on the effective date of this Act and legal interest shall cease to run as of that date.

- 1 Section 3. This Act shall become effective on July 1, 2011; if vetoed by the governor
- 2 and subsequently approved by the legislature, this Act shall become effective on July 1,
- 3 2011, or on the day following such approval by the legislature, whichever is later.
