HOUSE CONCURRENT RESOLUTION NO. 105

BOARDS/COMMISSIONS: Requests the legislative auditor to issue a report concerning boards and commissions that have failed to comply with the requirements of Chapter 20 of Title 49 of the Louisiana Revised Statutes of 1950

1 A CONCURRENT RESOLUTION

2 To urge and request that the legislative auditor prepare and issue a report concerning boards
3 and commissions that have failed to comply with the requirements of Chapter 20 of
4 Title 49 of the Louisiana Revised Statutes of 1950.

5 WHEREAS, Chapter 20 of Title 49 of the Louisiana Revised Statutes of 1950
6 requires that the commissioner of administration establish a website on which various
7 information on certain boards and commissions is placed so as to make that information
8 available to Louisiana citizens; and

9 WHEREAS, the boards to which this law applies are the State Civil Service
10 Commission, the Board of Commissioners of the Louisiana Stadium and Exposition District,
11 licensing boards, and certain boards that have the authority to expend, disburse, or invest ten
12 thousand dollars or more of funds in a fiscal year; and

13 WHEREAS, the law requires that the following be submitted to the commissioner
14 and posted on the website: notices and minutes of meetings; statutory citations to provisions
15 specifically creating and providing for the entity; contact information, including a mailing
16 address, an e-mail address, and a website address; membership information, including the
17 names, compensation, terms, length of service, and method of selection of members; per
18 diem and reimbursement for travel expense information; employee information; financial
19 and budget information; and rules, regulations, and procedures of the entity; and

1 WHEREAS, the commissioner has created the website and it is well designed and
2 user friendly and provides a great resource for citizens as was anticipated by the legislature
3 in enacting the law; and

4 WHEREAS, there is not yet full compliance with the requirement of the law as some
5 entities have not provided any information and others have not provided all that is required.

6 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
7 urge and request the legislative auditor to prepare and issue a report concerning boards and
8 commissions that have failed to comply with the requirements of Chapter 20 of Title 49 of
9 the Louisiana Revised Statutes of 1950.

10 BE IT FURTHER RESOLVED that the legislative auditor is requested to submit the
11 report, in compliance with R.S. 24:771 and 772, prior to January 1, 2012.

12 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
13 legislative auditor.
