HOUSE CONCURRENT RESOLUTION NO. 22

BY REPRESENTATIVES MORRIS AND GEYMANN

BUDGETARY PROCEDURES: Reduces the expenditure limit for Fiscal Year 2011-2012

A CONCURRENT RESOLUTION

2	To direct the commissioner of administration to change the expenditure limit for Fiscal Year
3	2011-2012.
4	WHEREAS, the expenditure limit provided for in Article VII, Section 10(C)(1) of
5	the Constitution of Louisiana for Fiscal Year 2011-2012 is established as Fourteen Billion
6	Nine Hundred Twelve Million Eight Hundred Eighty-Five Thousand Six Hundred Forty and
7	No/100 (\$14,912,885,640.00) Dollars; and
8	WHEREAS, the state budget indicated that appropriated expenditures for Fiscal Year
9	2010-2011 were Eleven Billion Four Hundred Twenty-One Million Seven Hundred Ninety-
10	Four Thousand Five Hundred Forty-Four and No/100 (\$11,421,794,544.00) Dollars and
11	anticipated adjustments were Twenty-Four Million Eight Hundred Eighty-Two Thousand
12	Six Hundred Thirty-Nine and No/100 (\$24,882,639.00) Dollars; and
13	WHEREAS, expenditures and anticipated adjustments for Fiscal Year 2010-2011
14	times a growth factor of three and thirty-four hundredths (3.34) percent equals Eleven
15	Billion Eight Hundred Twenty-Eight Million Nine Hundred Ninety-Six Thousand Two
16	Hundred One and No/100 (\$11,828,996,201.00) Dollars; and
17	WHEREAS, Article VII, Section 10(C)(2) of the Constitution of Louisiana provides
18	that the expenditure limit may be changed in any fiscal year by a favorable vote of two-thirds
19	of the elected members of each house and that any such change in the expenditure limit shall
20	be approved by the passage of a specific legislative instrument which clearly states the intent
21	to change the limit; and

1 WHEREAS, R.S. 39:52.1 of the Louisiana Revised Statutes of 1950 provides that

- 2 a change to the expenditure limit shall be made pursuant to a concurrent resolution adopted
- 3 by a favorable vote of two-thirds of the elected members of each house directing the
- 4 commissioner of administration to change the expenditure limit to a designated amount for
- 5 a specified fiscal year.
- 6 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana, two-thirds of
- 7 the elected members of each house concurring, does hereby direct the commissioner of
- 8 administration to change the expenditure limit for Fiscal Year 2011-2012 to Eleven Billion
- 9 Eight Hundred Twenty-Eight Million Nine Hundred Ninety-Six Thousand Two Hundred
- 10 One and No/100 (\$11,828,996,201.00) Dollars.
- 11 BE IT FURTHER RESOLVED that the provisions of this Resolution shall be
- 12 construed to affect the expenditure limit for Fiscal Year 2012-2013 and thereafter in
- 13 accordance with Article VII, Section 10(C) of the Constitution of Louisiana.
