HOUSE CONCURRENT RESOLUTION NO. 231

SCHOOLS/FINANCE-MFP: Requests the State Board of Elementary and Secondary Education to include increased per pupil funding as part of FY 2015-16 base per pupil funding and to maintain at least that combined amount for FY 2016-17 MFP

1	A CONCURRENT RESOLUTION
2	To urge and request the State Board of Elementary and Secondary Education to recognize
3	and include increased per pupil funding to parish and city school systems, as
4	provided in House Bill No. 1 of the 2015 Regular Session, as part of the 2015-2016
5	Fiscal Year base per pupil amount when developing and adopting a minimum
6	foundation program formula for the 2016-2017 Fiscal Year and to maintain at least
7	that combined amount of per pupil funding for the 2016-2017 Fiscal Year minimum
8	foundation program formula.
9	WHEREAS, Article VIII, Section 13(B) of the Constitution of Louisiana requires the
10	State Board of Elementary and Secondary Education to develop and adopt, annually, a
11	formula which is to be used to determine the cost of a minimum foundation program of
12	education in all public elementary and secondary schools as well as to allocate equitably the
13	funds to parish and city school systems; and
14	WHEREAS, on March 6, 2015, the State Board of Elementary and Secondary
15	Education adopted such a formula to determine the cost and allocation of funds for the 2015-
16	2016 Fiscal Year and on March 13, 2015, submitted it to the legislature; and
17	WHEREAS, such formula was timely submitted to the legislature, and an instrument
18	providing for legislative approval of the formula was introduced for consideration, House
19	Concurrent Resolution No. 18; and

1	WHEREAS, House Concurrent Resolution No. 18 passed the House but was deferred
2	by the Senate Committee on Education on June 4, 2015; and
3	WHEREAS, the state constitution provides that if the legislature does not approve
4	the recommendation of the State Board of Elementary and Secondary Education, the
5	minimum foundation program formula last approved remains in effect; and
6	WHEREAS, the last valid minimum foundation program formula was approved in
7	Senate Concurrent Resolution No. 55 of the 2014 Regular Session; and
8	WHEREAS, the legislature finds that increasing the base per pupil amount of
9	funding for public schools by one and three hundred seventy-five thousandths percent
10	(1.375%) would raise that amount from \$3,961 to \$4,015 per student, generating money to
11	partially cover inflationary increases in expenditures and critical education initiatives; and
12	WHEREAS, the base per pupil amount of funding in the minimum foundation
13	program may be adjusted only through legislative approval of a formula adopted by the State
14	Board of Elementary and Secondary Education that provides for such an adjustment; and
15	WHEREAS, in order to provide for an increase in the base per pupil amount of
16	funding in the minimum foundation program, the legislature intends to amend House Bill
17	No. 1 of the 2015 Regular Session to provide for such an increase outside of the minimum
18	foundation program formula by directing the state Department of Education to allocate such
19	funds in the same manner in which they would have been allocated pursuant to the minimum
20	foundation program formula; and
21	WHEREAS, it is the intent of the legislature that this increase in the per pupil
22	amount, although provided for outside of the minimum foundation program formula for the
23	2015-2016 Fiscal Year, be recognized and included by the State Board of Elementary and
24	Secondary Education as a minimum base per pupil amount in future years.
25	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
26	urge and request the State Board of Elementary and Secondary Education to recognize and
27	include the increased base per pupil amount in funding to parish and city school systems, as
28	provided in House Bill No. 1 of the 2015 Regular Session, as part of the 2015-2016 Fiscal
29	Year base per pupil amount when developing and adopting a minimum foundation program
30	formula for the 2016-2017 Fiscal Year.
