COMMENDATIONS: Commends Sgt. Scott Bullitt on his service and sacrifice to the state of Louisiana

1 A CONCURRENT RESOLUTION

2 To commend Sergeant Scott Bullitt on his exemplary service to and sacrifice for Louisiana.

3 WHEREAS, Scott Bullitt, an avid sportsman, joined the Louisiana Department of  
4 Wildlife and Fisheries Enforcement Division as a cadet in 2009 and graduated in the  
5 department's twenty-fifth class in 2010; and

6 WHEREAS, in 2012, Scott Bullitt achieved the rank of LDWF Enforcement  
7 Sergeant; and

8 WHEREAS, Sgt. Bullitt has dedicated his professional life to protecting this state's  
9 natural resources and has received numerous awards for his service including the LDWF  
10 Enforcement Region 2 Officer of the Year Award in 2012, the LDWF Enforcement  
11 Waterfowl Officer of the Year Award in 2014, and the LDWF Boating Officer of the Year  
12 Award in 2015; and

13 WHEREAS, Sgt. Bullitt was also awarded the Louisiana Highway Safety  
14 Commission DWI Enforcement Award for having issued the most DWI citations for the  
15 Louisiana Department of Wildlife and Fisheries in 2014; and

16 WHEREAS, Sgt. Bullitt has performed admirably as one of the top drug recognition  
17 experts in the state of Louisiana and advanced to the level of instructor at the LDWF  
18 Academy for new cadets and with other law enforcement agencies throughout North  
19 Louisiana; and

1           WHEREAS, Sgt. Bullitt has demonstrated an exceptional knowledge in his field and  
2 has excelled at every level of wildlife law enforcement that he has undertaken throughout  
3 his career; and

4           WHEREAS, while on patrol on the Russell Sage Wildlife Management Area in  
5 Ouachita Parish, on May 21, 2015, Sgt. Bullitt was shot in the line of duty; and

6           WHEREAS, it is appropriate to recognize and honor Sgt. Scott Bullitt for his  
7 exemplary dedication and service to the citizens of Louisiana in protecting this state's natural  
8 resources while facing personal danger.

9           THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby  
10 commend Sgt. Scott Bullitt for his exemplary service to the people of Louisiana and does  
11 hereby extend its best wishes for a full and fast recovery.

12           BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted  
13 to Sgt. Scott Bullitt.
