A CONCURRENT RESOLUTION

To commend Sergeant Scott Bullitt on his exemplary service to and sacrifice for Louisiana.

WHEREAS, Scott Bullitt, an avid sportsman, joined the Louisiana Department of Wildlife and Fisheries Enforcement Division as a cadet in 2009 and graduated in the department's twenty-fifth class in 2010; and

WHEREAS, in 2012, Scott Bullitt achieved the rank of LDWF Enforcement Sergeant; and

WHEREAS, Sgt. Bullitt has dedicated his professional life to protecting this state's natural resources and has received numerous awards for his service including the LDWF Enforcement Region 2 Officer of the Year Award in 2012, the LDWF Enforcement Waterfowl Officer of the Year Award in 2014, and the LDWF Boating Officer of the Year Award in 2015; and

WHEREAS, Sgt. Bullitt was also awarded the Louisiana Highway Safety Commission DWI Enforcement Award for having issued the most DWI citations for the Louisiana Department of Wildlife and Fisheries in 2014; and

WHEREAS, Sgt. Bullitt has performed admirably as one of the top drug recognition experts in the state of Louisiana and advanced to the level of instructor at the LDWF Academy for new cadets and with other law enforcement agencies throughout North Louisiana; and

WHEREAS, Sgt. Bullitt has demonstrated an exceptional knowledge in his field and has excelled at every level of wildlife law enforcement that he has undertaken throughout his career; and

WHEREAS, while on patrol on the Russell Sage Wildlife Management Area in Ouachita Parish, on May 21, 2015, Sgt. Bullitt was shot in the line of duty; and

WHEREAS, it is appropriate to recognize and honor Sgt. Scott Bullitt for his exemplary dedication and service to the citizens of Louisiana in protecting this state's natural resources while facing personal danger.

THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby commend Sgt. Scott Bullitt for his exemplary service to the people of Louisiana and does hereby extend its best wishes for a full and fast recovery.
