HOUSE CONCURRENT RESOLUTION NO. 57

SOCIAL SECURITY SYS: Memorializes congress to review and consider eliminating the Government Pension Offset (GPO) and the Windfall Elimination Provision (WEP) Social Security benefit reductions

1	A CONCURRENT RESOLUTION
2	To memorialize the Congress of the United States to review and consider eliminating
3	provisions of federal law which reduce Social Security benefits for those receiving
4	pension benefits from federal, state, or local government retirement or pension
5	systems, plans, or funds.
6	WHEREAS, the Congress of the United States has enacted both the Government
7	Pension Offset (GPO), reducing the spousal and survivor Social Security benefit, and the
8	Windfall Elimination Provision (WEP), reducing the earned Social Security benefit for any
9	person who also receives a public pension benefit; and
10	WHEREAS, the intent of congress in enacting the GPO and the WEP provisions was
11	to address concerns that a public employee who had worked primarily in federal, state, or
12	local government employment might receive a public pension in addition to the same Social
13	Security benefit as a person who had worked only in employment covered by Social Security
14	throughout his career; and
15	WHEREAS, the purpose of congress in enacting these reduction provisions was to
16	provide a disincentive for public employees to receive two pensions; and
17	WHEREAS, the GPO negatively affects a spouse or survivor receiving a federal,
18	state, or local government retirement or pension benefit who would also be entitled to a
19	Social Security benefit earned by a spouse; and

1	WHEREAS, the GPO formula reduces the spousal or survivor Social Security benefit
2	by two-thirds of the amount of the federal, state, or local government retirement or pension
3	benefit received by the spouse or survivor, in many cases completely eliminating the Social
4	Security benefit; and
5	WHEREAS, nine out of ten public employees affected by the GPO lose their entire
6	spousal benefits, even though their spouses paid Social Security taxes for many years; and
7	WHEREAS, the GPO often reduces spousal benefits so significantly it makes the
8	difference between self-sufficiency and poverty; and
9	WHEREAS, the GPO has a harsh effect on thousands of citizens and undermines the
10	original purpose of the Social Security dependent/survivor benefit; and
11	WHEREAS, the GPO negatively impacts approximately 28,825 Louisianians; and
12	WHEREAS, the WEP applies to those persons who have earned federal, state, or
13	local government retirement or pension benefits, in addition to working in employment
14	covered under Social Security and paying into the Social Security system; and
15	WHEREAS, the WEP reduces the earned Social Security benefit using an averaged
16	indexed monthly earnings formula and may reduce Social Security benefits for affected
17	persons by as much as one-half of the retirement benefit earned as a public servant in
18	employment not covered under Social Security; and
19	WHEREAS, the WEP causes hardworking individuals to lose a significant portion
20	of the Social Security benefits that they earn themselves; and
21	WHEREAS, the WEP negatively impacts approximately 27,755 Louisianians; and
22	WHEREAS, because of these calculation characteristics, the GPO and the WEP have
23	a disproportionately negative effect on employees working in lower-wage government jobs,
24	like policemen, firefighters, teachers, and state employees; and
25	WHEREAS, these provisions also have a greater adverse effect on women than on
26	men because of the gender differences in salary that continue to plague our nation and
27	because of the longer life expectancy of women; and
28	WHEREAS, Louisiana is making every effort to improve the quality of life of its
29	citizens and to encourage them to live here lifelong, yet the current GPO and WEP
30	provisions compromise that quality of life; and

1	WHEREAS, retired individuals negatively affected by GPO and WEP have
2	significantly less money to support their basic needs and sometimes have to turn to
3	government assistance programs; and
4	WHEREAS, the GPO and the WEP penalize individuals who have dedicated their
5	lives to public service by taking away benefits they have earned; and
6	WHEREAS, our nation should respect, not penalize, public servants; and
7	WHEREAS, the number of people affected by GPO and WEP is growing every day
8	as more and more people reach retirement age; and
9	WHEREAS, the GPO and WEP are established in federal law, and repeal of the GPO
10	and the WEP can only be enacted by the United States Congress.
11	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
12	memorialize the Congress of the United States to review the Government Pension Offset and
13	the Windfall Elimination Provision Social Security benefit reductions and to consider
14	eliminating or reducing them by enacting the Social Security Fairness Act of 2011 (H.R.
15	1332), the Public Servant Retirement Protection Act of 2011 (S. 113), or a similar
16	instrument.
17	BE IT FURTHER RESOLVED that a copy of this Resolution shall be transmitted
18	to the secretary of the United States Senate and the clerk of the United States House of
19	Representatives and to each member of the Louisiana delegation to the United States
20	Congress.
