5	WHEREAS, offering competitive family and parental leave to employees can be an
6	effective recruiting tool, especially in a competitive labor market; and
7	WHEREAS, competitive family and parental leave policies can also enhance the
8	work environment and culture and can decrease attrition and increase employee retention;

0	WHEREAS, all classified state employees are subject to rules and regulations
1	regarding leave adopted by the State Civil Service Commission; and
12	WHEREAS, unclassified employees in the executive branch of state government, in
13	the legislative branch of state government, and in the judicial branch of state government are
14	subject to leave policies adopted by the various appointing authorities; and
15	WHEREAS, it is important to understand how the policies affecting family and
16	parental leave for state employees are similar and different; and
17	WHEREAS, it is important to understand how these policies applicable to state
18	employees compare with competitive best practices.
19	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
20	urge and request the legislative auditor to compile all policies relative to family and parental
21	leave for state employees, to compare such policies, and to report on the status of family and
