A RESOLUTION

To commend former state representative Clifton "Clif" Richardson for his service and many contributions to Central, East Baton Rouge Parish, and the Louisiana House of Representatives.

WHEREAS, former state representative Clif Richardson resigned his seat in the House of Representatives early in 2013, and it is appropriate to commend him for his many years of dedicated service; and

WHEREAS, during his tenure in the House of Representatives, Mr. Richardson served on the civil law, education, and municipal, parochial and cultural affairs committees; and

WHEREAS, Mr. Richardson is a member of several civic and business associations, including Cooking for Our Neighbors and Kids Campaigns, City-Parish Electrical Board, Central Chamber of Commerce, Central Area Business Association, and the Central Volunteer Fire Department; and

WHEREAS, Mr. Richardson has also served as a deacon and chairman of the Stewardship Committee at Fellowship Baptist Church, as a coach of the Central Area Youth League baseball and the Christian Elementary Football League teams, and as chairman of the American Subcontractors Association; and

WHEREAS, Mr. Richardson merits a sincere measure of commendation for his service to the Central community, East Baton Rouge Parish, and to the Louisiana House of Representatives.

THEREFORE, BE IT RESOLVED that the House of Representatives of the Legislature of Louisiana does hereby commend Clif Richardson for his many years of highly effective service as a member of the House of Representatives, does hereby record for posterity his contributions to East Baton Rouge Parish and the community of Central, and does hereby extend to him best wishes for health and happiness in the future.
