CONDOLENCES: Expresses condolences upon the death of automobile sales entrepreneur and businessman Gerry Lane of Baton Rouge

A RESOLUTION

2	To express the condolences of the House of Representatives of the Legislature of Louisiana
3	upon the death of Gerald Ray "Gerry" Lane, of Baton Rouge.
4	WHEREAS, on Friday, May 3, 2013, Baton Rouge businessman, resident, and
5	philanthropist Gerald Ray "Gerry" Lane traveled to his eternal rest, departing from the
6	company of family who stood by him; and
7	WHEREAS, the slogan, "You can count on Gerry Lane" typified not only Mr. Lane's
8	commitment to his auto sales and service businesses, but spoke of his generosity to those less
9	fortunate than he; and
10	WHEREAS, born on February 15, 1931, in Red Mount, Oklahoma, Mr. Lane was
1	raised in the heart of Oklahoma's Dust Bowl during the Depression but he embraced the
12	values of vision, hard work, and pursuing good ideas and sought his fortune in California;
13	and
14	WHEREAS, in order to survive, Mr. Lane reluctantly took a job in San Diego as a
15	car salesman, and on his first day at work, on June 3, 1953, at the tender age of twenty-two,
16	Mr. Lane sold his first automobile; and
17	WHEREAS, three years later, Mr. Lane took a job selling cars at Capitol City Ford
18	in Baton Rouge, and soon after being hired away from Capitol City Ford by Polk Chevrolet,
19	Gerry Lane became the youngest automobile sales general manager in the country at the age
20	of twenty-six; and

1	WHEREAS, frustrated at not being able to obtain ownership of an automobile
2	business in Baton Rouge, in 1966 Gerry Lane seized the opportunity to purchase a failing
3	dealership in Bay St. Louis, Mississippi, and made it a success within a year; and
4	WHEREAS, after having duplicated his automobile dealership success in Pascagoula,
5	Gulfport, and Lucedale, Mississippi, and in Gonzales, Louisiana, Gerry Lane took advantage
6	of the chance to return to his beloved Baton Rouge when his mentor Herb Polk, the owner
7	of Polk Chevrolet, was ready to sell his dealership; and
8	WHEREAS, under the name of Gerry Lane Chevrolet, Gerry Lane guided the former
9	Polk Chevrolet, which was thirteenth in the Baton Rouge automotive sales market prior to
10	his purchase of the franchise, to become the number one selling automobile dealership in the
11	market; and
12	WHEREAS, one of Gerry Lane's many impressive gifts was his willingness to share
13	the lessons he had learned in sixty years of car sales; Mr. Lane is estimated to have hired and
14	trained five thousand salespeople and three thousand managers; and
15	WHEREAS Gerry Lane received an abundance of awards in his business life,
16	including Time magazine's Dealer of the Year; the National Lifetime Achievement Award
17	from General Motors Acceptance Corporation; District Dealer of the Year, an award he won
18	four times; the Business Report Executive of the Year Award; the Pete Goldsby Award from
19	the American Advertising Federation; and the Better Business Bureau's Douglas Manship
20	Sr. Torch Award for professional ethics; and
21	WHEREAS, as a monument to his unwavering support of Louisiana State University
22	men's baseball, a bronze plaque honoring Mr. Lane has been placed in Gerry Lane
23	Championship Plaza at Alex Box Stadium on the Louisiana State University campus in
24	Baton Rouge; and
25	WHEREAS, Gerry Lane was known for his penchant for giving to others, and
26	instilled in his family and employees the value of contributing to the local community, chief
27	among them the YMCA of the Capital Area, which received for its youth sports programs
28	a significant portion of the nearly thirty million dollars Gerry Lane and his family donated
29	to local charities and organizations, including the March of Dimes, the Cystic Fibrosis
30	Foundation, Arc of Baton Rouge, and Louisiana State University's Rural Life Museum; and

1 WHEREAS, as a former rodeo rider, Gerry Lane saw fit to become an annual 2 sponsor of the Angola Rodeo, beginning in 1970, and often offered jobs to inmates upon 3 their release from prison, sharing with them his philosophy that hard work produces fruitful 4 results; and 5 WHEREAS, the remarkable life of this longtime Baton Rouge personality has been 6 chronicled by author Leo Honeycutt in a biography entitled, "Gerry Lane: An American 7 Success Story"; and 8 WHEREAS, Gerald Ray "Gerry" Lane will be sorely missed yet fondly remembered 9 by his wife of fifty-five years, Faye Rogan Lane, his sons, David and wife Cindy, and Eric 10 and wife Lisa, his daughter Saundra, and family, friends, and employees of the many facets 11 of the crown that is Lane Enterprises, to which he lent his life and created a legacy that is 12 certain to endure in the years to come. 13 THEREFORE, BE IT RESOLVED that the members of the House of Representatives 14 of the Legislature of Louisiana do hereby extend earnest and sincere condolences to the family of Gerald Ray "Gerry" Lane, do hereby honor the memory of this man who 15 16 transformed automotive sales in the Gulf South Region of the United States, and do hereby 17 express their respect and appreciation for a life well lived in the person of Baton Rouge's 18 own Gerry Lane, a man you could count on. 19 BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted 20 to Mrs. Faye Lane.
