| 14 | female governor of Louisiana, having served as the campaign chairman for Governor |
| 15 | Kathleen Babineaux Blanco in north Louisiana; and |
| 16 | WHEREAS, Mr. Roppolo was actively involved in making the annual Red Mass in |
| 17 | Shreveport a successful salute to the legal profession and a special occasion for judges, |
| 18 | lawyers, and law enforcement officials of all faiths to pray together to ask for God's blessing |
| 19 | and guidance; and |

1 WHEREAS, Mr. Roppolo was a founder of the South Shreveport Business 2 Association, an organization dedicated to the success of businesses in a rapidly growing area 3 of his community; and 4 WHEREAS, Mr. Roppolo has been a confidant and supporter of entrepreneurs in 5 Shreveport and has helped many individuals obtain financing for their ventures, many of 6 whom have seen their efforts grow into successful businesses; and 7 WHEREAS, Mr. Roppolo's guidance and counsel have been sought by private 8 citizens, leaders in business and industry, and politicians on the local, state, and national 9 levels for more than seven decades; and 10 WHEREAS, Angelo Roppolo, who is modest and seldom takes credit for his 11 achievements, is known for avoiding the spotlight and for his unwavering loyalty to his 12 friends and his core beliefs and principles, and all who know him are better for it; and 13 WHEREAS, Mr. Roppolo has shown himself to be a man of uncommon strength, 14 dignity, and humility, and he has the love and respect of all who know him and all whose 15 lives he has touched; and 16 WHEREAS, although a party loyalist, Mr. Roppolo stands for righteousness and 17 justice and has never hesitated to support any candidate who has challenged the norm, 18 improved employment and education conditions, and instilled hope through change; and 19 WHEREAS, Mr. Roppolo has always exhibited praise and gratitude toward those in 20 the armed services and for the men and women who protect this state and nation twenty-four 21 hours a day, seven days a week, and three hundred sixty-five days a year; and 22 WHEREAS, a rare and caring man, Mr. Roppolo sees no color or religion and is truly 23 a source of inspiration that is Heaven-sent; and 24 WHEREAS, Angelo Roppolo is widely beloved, respected, and admired and merits 25 a special measure of sincere and heartfelt commendation for the indelible mark he has left 26 on the state of Louisiana. 27 THEREFORE, BE IT RESOLVED that the House of Representatives of the 28 Legislature of Louisiana does hereby commend Angelo Roppolo of Shreveport for his 29 extraordinary accomplishments, does hereby recognize and record for posterity his singular
