MUNICIPALITIES/NO: Requests that the owners of *The Times-Picayune* continue to publish a daily print edition, commends the newspaper's staff, and recognizes the singular place the newspaper holds in New Orleans history and in citizens' daily lives

1	A RESOLUTION
2	To urge and request the owners of <i>The Times-Picayune</i> to continue to publish a daily print
3	edition of the newspaper, to commend the staff of the newspaper for steadfast
4	dedication to excellence in journalism, and to recognize the singular place the
5	newspaper holds in the history of New Orleans and in the lives of the citizens who
6	rely on its daily print edition for news and information.
7	WHEREAS, the daily print edition of The Times-Picayune has long been a fixture
8	in the lives of the citizens of New Orleans; and
9	WHEREAS, the newspaper is owned by Advance Publications, which is owned by
10	the Newhouse family; and
11	WHEREAS, on Thursday, May 24th, 2012, Advance Publications announced that
12	beginning in the fall of 2012, the print edition of <i>The Times-Picayune</i> will be published on
13	a reduced schedule of only three days a week, Wednesday, Friday, and Sunday; and
14	WHEREAS, it was also announced that there will be a reduction in the size of the
15	newspaper's workforce, which is composed of extremely talented and loyal employees; and
16	WHEREAS, the news that The Times-Picayune will no longer be printed on a daily
17	basis has been met with widespread shock and profound sorrow, and many citizens consider
18	the idea of the city of New Orleans without a daily newspaper simply unfathomable; and

1 WHEREAS, many people who rely on the print edition of *The Times-Picayune* for 2 daily news do not have access to the Internet and will be without a source for critical news 3 and information four days a week; and

- 4 WHEREAS, for its staff's consistently exceptional work, The Times-Picayune has 5 been the deserving recipient of numerous awards, including several Pulitzer Prizes, such as 6 those in 2006 in the category of Public Service "for its heroic, multi-faceted coverage of 7 Hurricane Katrina and its aftermath, making exceptional use of the newspaper's resources 8 to serve an inundated city even after evacuation of the newspaper plant" and in the category 9 of Breaking News "for its courageous and aggressive coverage of Hurricane Katrina, 10 overcoming desperate conditions facing the city and the newspaper"; and
- 11 WHEREAS, The Times-Picayune, with origins dating back to 1837, is not merely a 12 newspaper but a true institution with a passionately devoted readership spanning multiple 13 centuries and generations; and
- 14 WHEREAS, daily delivery of *The Times-Picayune* is a tradition woven into the very 15 fabric of New Orleans, and removing it from doorsteps four days a week will have a 16 significant impact not only on the news consumption but also on the culture of the Crescent 17 City.
- 18 THEREFORE, BE IT RESOLVED that the House of Representatives of the 19 Legislature of Louisiana does hereby urge and request the owners of *The Times-Picayune* 20 to continue to publish a daily print edition of the newspaper.
- 21 BE IT FURTHER RESOLVED that the House of Representatives does hereby 22 commend the staff of The Times-Picayune for steadfast dedication to excellence in 23 journalism.
- 24 BE IT FURTHER RESOLVED that the House of Representatives does hereby 25 recognize and record for posterity the singular place The Times-Picayune holds not only in 26 the annals of the history of the city of New Orleans but in the lives of the citizens who rely 27 on its daily print edition for vital news and information.
- 28 BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted 29 to Steven Newhouse, Donald Newhouse, Ashton Phelps, Jr., and Ricky Mathews.
