COMMENDATIONS: Commends Bunkie City Clerk Cynthia Dauzat upon her retirement

A RESOLUTION

2	To commend Cynthia Dauzat upon the occasion of her retirement as city clerk for the City
3	of Bunkie after thirty-two years of service.
4	WHEREAS, Cynthia Dauzat was hired as deputy city clerk for Bunkie on May 3,
5	1982, and served in that position through September 13, 1993, when she was appointed city
6	clerk for Bunkie on September 14, 1993; and
7	WHEREAS, at the time of her retirement on May thirty-first of this year, Cynthia
8	Dauzat will have served the City of Bunkie for a total of thirty-two years; and
9	WHEREAS, during her time with the City of Bunkie, Cynthia Dauzat completed the
10	annual Louisiana Clerks Institute held in Baton Rouge, Louisiana, where she received the
11	designation of Certified Municipal Clerk from the International Institute of Municipal Clerks
12	on November 4, 1988; and
13	WHEREAS, after further education through the Louisiana Clerks Institute and
14	various regional meetings, Cynthia Dauzat was also awarded the title of Certified Municipal
15	Clerk/Advanced Academy of Education on October 25, 1999, by the International Institute
16	of Municipal Clerks; and
17	WHEREAS, on February 28, 2000, Cynthia Dauzat received the lifetime designation
18	of Master Municipal Clerk from the International Institute of Municipal Clerks, a new
19	designation and the highest recognition that a city clerk can receive; and

1 WHEREAS, during her years as city clerk, Cynthia Dauzat also served as president 2 of the Louisiana Municipal Clerks for the years 2000 to 2001, in addition to serving on its 3 various committees throughout the years; and 4 WHEREAS, Cynthia Dauzat also had the honor of serving as the city clerk board member on the Louisiana Municipal Advisory and Technical Services Board, along with 5 6 mayors and aldermen throughout the state, from November 6, 2002, through May 31, 2014; 7 and 8 WHEREAS, Cynthia Dauzat also served as president for four years, from 2006 9 through 2010, of such Louisiana Municipal Advisory and Technical Services Board, which 10 has the responsibility of administering the insurance premium tax and occupational license 11 tax collection program for municipalities throughout this state; and 12 WHEREAS, on a personal level, Cynthia Dauzat has been a member of the Bunkie 13 Rotary Club for nineteen years, since September 1994, serving as its president twice, from 14 2001 to 2002 and from 2010 to 2011; and 15 WHEREAS, Cynthia Dauzat additionally became a Paul Harris Fellow on May 24, 16 2010, and has served as chairman of Bunkie's Christmas Parade for the last several years. 17 THEREFORE, BE IT RESOLVED that the House of Representatives of the Legislature of Louisiana does hereby commend Cynthia Dauzat upon the occasion of her 18 19 retirement as city clerk for the City of Bunkie after thirty-two years of service. 20 BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted 21 to Cynthia Dauzat.
