**HOUSE RESOLUTION NO. 202**

FIRE PROTECT/FIREMEN: Requests the Professional Firefighters Assoc. of La. to study issues related to making municipal fire civil service laws applicable to not-for-profit organizations that enter into cooperative endeavors with certain municipalities, parishes, and fire protection districts to provide fire protection services

A RESOLUTION

2 To urge and request the Professional Firefighters Association of Louisiana to study the 3 issues related to making municipal fire civil service laws applicable to not-for-profit 4 organizations that enter into cooperative endeavors with certain municipalities, 5 parishes, and fire protection districts to provide fire protection services. 6 WHEREAS, Article X, Section 16 of the Constitution of Louisiana establishes a 7 system of classified fire and police civil service in each municipality having a population 8 exceeding thirteen thousand and operating a regularly paid fire and municipal police 9 department and in each parish and fire protection district operating a regularly paid fire 10 department; and 11 WHEREAS, R.S. 33:2471 et seq. and R.S. 33:2531 et seq. establish classified civil 12 service systems for policemen and firemen employed in municipalities with a population of 13 not less than seven thousand and not more than two hundred fifty thousand persons 14 according to the latest federal decennial census and in all parishes and fire protection 15 districts; and 16 WHEREAS, R.S. 33:2471 et seq. and R.S. 33:2581 et seq. provide provisions that 17 govern employees in the classified fire and police service, including municipal fire and 18 police civil service boards, classification plans, employment lists, reinstatement and 19 reemployment, admission to tests, certification and appointment, leaves of absences, lay-20 offs, and appeals; and

1	WHEREAS, many not-for-profit organizations enter into cooperative endeavors with
2	municipalities, parishes, and fire protection districts governed by the provisions of R.S.
3	33:2471 et seq. and R.S. 33:2581 et seq. to provide fire protection services and employ
4	persons in positions that have as their primary duty and responsibility one of the following:
5	(1) The chief and assistant chiefs; the intradepartmental division, bureau, squad,
6	platoon, and company officers of the fire department.
7	(2) Firefighting.
8	(3) Fire prevention; inspection.
9	(4) Driving, tillering, and operation of fire apparatus.
10	(5) Operations and maintenance of radio, fire alarm, or signal system.
11	(6) Fire department instructors in employee training.
12	(7) Fire salvage and overhauling services, first aid, advanced life support, and
13	emergency medical services.
14	(8) Automotive or fire apparatus repairs, if such service is operated exclusively by
15	and for either or both the fire or police department.
16	(9) Secretary to the chief. Departmental records clerk; and
17	WHEREAS, the employees of not-for-profit organizations that enter into such
18	cooperative endeavors are not covered by the provisions of R.S. 33:2471 et seq. and R.S.
19	33:2581 et seq; and
20	WHEREAS, many of the not-for-profit organizations do not provide adequate
21	protections for their employees who constantly work under life threatening conditions; and
22	WHEREAS, the employees of not-for-profit organizations that enter into cooperative
23	endeavors with municipalities, parishes, and fire protection districts governed by the
24	provisions of R.S. 33:2471 et seq. and R.S. 33:2581 et seq. provide the same service as
25	employees of the classified fire service and deserve to have the same protections; and
26	WHEREAS, many not-for-profit organizations that enter into such cooperative
27	endeavors have not been open to providing adequate protections for their employees.
28	THEREFORE, BE IT RESOLVED that the House of Representatives of the
29	Legislature of Louisiana does hereby urge and request the Professional Firefighters
30	Association of Louisiana to study the issues related to making municipal fire civil service
