6 and he has served as a member of the House Committee on Appropriations, the House  
7 Committee on House and Governmental Affairs, the House Committee on Retirement, the  
8 House Committee on Commerce, the House Committee on Natural Resources, and the Joint  
9 Legislative Committee on the Budget; and

10           WHEREAS, during his time in the House of Representatives, Representative  
11 Geymann has worked on and supported many important pieces of legislation including a rule  
12 now known as the "Geymann Rule", which stipulates that a two-thirds vote of the House is  
13 needed to approve certain expenditures of nonrecurring revenue; and

14           WHEREAS, as he prepares to embark on the next exciting and productive chapter  
15 of his life, Representative Geymann merits a sincere measure of commendation for his  
16 singular contributions and the exemplary strides he has taken as an exceptional member of  
17 the Louisiana House of Representatives.

18           THEREFORE, BE IT RESOLVED that the House of Representatives of the  
19 Legislature of Louisiana does hereby commend the Honorable Brett F. Geymann; does  
20 hereby extend honor and recognition to him for his outstanding accomplishments,
