1 A RESOLUTION

2 To commend Child Advocacy Centers of Louisiana (CACLA), the Louisiana Court
3 Appointed Special Advocates Association (LACASA) and Prevent Child Abuse
4 Louisiana (PCAL) for their efforts to provide for education and awareness
5 concerning the issues of child abuse and abandonment through the GEAUX BLUE
6 FOR KIDS! campaign and to recognize Thursday, April 18, 2013, as GEAUX BLUE
7 FOR KIDS! Day at the Louisiana State Capitol.

8 WHEREAS, the Child Advocacy Centers of Louisiana, the Louisiana Court
9 Appointed Special Advocates Association, and Prevent Child Abuse Louisiana have made
10 valuable contributions to Louisiana and have helped to make the state a better place for
11 children and families; and

12 WHEREAS, the member programs of these associations serve more than eleven
13 thousand children and reach more than twenty-five thousand families each year in the sixty-
14 four parishes of Louisiana through advocacy, education, and awareness efforts to support
15 child well-being, and research has demonstrated that these programs improve long-term
16 outcomes for children, reduce trauma for families, and save taxpayer money; and

17 WHEREAS, child abuse and abandonment most often occur in situations where
18 community resources are not available for victims to cope with stressful situations, and
19 preventing child abuse by strengthening families is beneficial for children and more cost-
20 effective for Louisiana taxpayers; and

1 WHEREAS, the GEAUX BLUE FOR KIDS! campaign encourages the citizens of
2 Louisiana to promote and advocate for all children based on a belief that all Louisianians
3 should contribute to the prevention of child abuse in order to ensure that every family has
4 the community support needed to raise children in a safe and nurturing environment.

5 THEREFORE, BE IT RESOLVED that the House of Representatives of the
6 Legislature of Louisiana does hereby commend Child Advocacy Centers of Louisiana, the
7 Louisiana Court Appointed Special Advocates Association, and Prevent Child Abuse
8 Louisiana and their member programs for their service and dedication to Louisiana's
9 children, families, and communities and does hereby recognize Thursday, April 18, 2013,
10 as GEAUX BLUE FOR KIDS! Day at the Louisiana State Capitol.

11 BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted
12 to the Louisiana CASA Association on behalf of the partnership.
