## A RESOLUTION

To commend John L. Pennison upon his retirement as deputy director of the Plaquemines

Port Harbor and Terminal District.

WHEREAS, Mr. Pennison was born on August 21, 1955, in Plaquemines Parish, he attended Delta Heritage Academy in Buras, Louisiana, he married Myra Sue Gandy on May 14, 1983, and they are the loving parents of their only daughter, Melanie; and

WHEREAS, Mr. Pennison currently maintains a Unites States Coast Guard Masters License and is active in the maritime navigation industry, serving as a navigational consultant in the shallow draft oil industry, particularly in the coastal areas of Plaquemines Parish; and
