A RESOLUTION

2	To express sincere and heartfelt condolences upon the death of Bishop Richard V. Allmon,
3	Sr., of Baton Rouge.
4	WHEREAS, it is with deep regret and profound sorrow that the members of the
5	Louisiana House of Representatives have learned of the death of Bishop Richard V. Allmon,
6	Sr., on Sunday, April 15, 2012, at the age of fifty-seven; and
7	WHEREAS, a native of Little Rock, Arkansas, Bishop Richard V. Allmon, Sr., began
8	his spiritual journey and ministry in the city of Shreveport before moving to Baton Rouge
9	and becoming a widely respected and admired pastor and community leader; and
10	WHEREAS, on August 21, 1954, Bishop Allmon was born to Veodis J. and Erma
1	Allmon, and upon graduating from high school near the top of his class, he received a full
12	scholarship to the United States Air Force Academy, proudly serving his country for nearly
13	five years and achieving the rank of sergeant; and
14	WHEREAS, on October 2, 1972, Bishop Allmon married his best friend and
15	childhood sweetheart, First Lady Lois S. Allmon, and they were baptized together on
16	August 18, 1974; to their union were born twelve children; and
17	WHEREAS, in 1977, Bishop Allmon received his calling to the ministry, and he
18	earned his certificate of ordination from the United Pentecostal Church International, an
19	associate of theology degree from Christian Life College, a bachelor of arts in Biblical
20	studies, and a master of divinity with a specialization in Biblical languages from New
21	Orleans Baptist Theological Seminary; and

1	WHEREAS, with his wife, Bishop Allmon served with great distinction and
2	dedication as the senior pastor of Full Gospel United Pentecostal Church in Baton Rouge
3	from 1983 until his passing, and they also served together as senior pastors of Tabernacle
4	of Truth United Pentecostal Church in Gray; and
5	WHEREAS, over the past three decades, Bishop Allmon led his family in the
6	development of churches throughout Louisiana and Mississippi and in establishing the S.E.
7	Mackey Community and Fitness Center and numerous community outreach facilities,
8	educational programs, and ministry alliances; and
9	WHEREAS, Bishop Allmon made his family and his ministry his top priorities, and
10	his passion for education led to the establishment of Full Gospel Christian Academy; and
11	WHEREAS, in addition to his significant local service, Bishop Allmon made his
12	mark throughout the state and beyond, serving as Presbyter at Large over the Louisiana
13	District of the United Pentecostal Church International and as a member of the executive
14	advisory board of the Apostolic Archives International and the nominating committee for
15	the Apostolic Ministerial Hall of Fame; and
16	WHEREAS, Bishop Allmon was preceded in death by his paternal grandparents,
17	Isaac Allmon, Sr., and Virginia Wright; his maternal grandfather, Willie Brown; his
18	maternal grandmother, Jessie "Ma Jessie" Momphrey Mitchell; one brother, Greg "Ross"
19	Stewart; his mother and father-in-law, Mable Straw Houston and Major Straw, Sr.; and his
20	brother-in-law Major Straw, Jr.; and
21	WHEREAS, left to cherish Bishop Allmon's memory are his wife of thirty-nine
22	years, Lois Straw Allmon; seven sons, Richard, Jr. (Demi), Raymond (Rhonda), Reginald,
23	Robert (Shawanda), Reuben, Ryan (Brittany), and Ramahd; five daughters, Renarda Parker,
24	Ravonne (Michael) Allmon-Smith, Rachel, Rebecca Allmon-Boatner, and Lois; two
25	brothers, Laurence (Carolyn) and Gregory, Sr. (Belva); five sisters, Cynthia (James) Woods,
26	Charlotte and Terry Allmon, Carol (Eddie) Watson, and Tracy (Anthony) Jemerson; two
27	sisters-in-law, Emma Jean Jones and Mabeline (Louie) Lewis; one brother-in-law, Larry
