SPECIAL DAY/WEEK/MONTH: Designates June 27, 2024, as Post-Traumatic Stress Injury Awareness Day in Louisiana

1 A RESOLUTION

2 To designate June 27, 2024, as Post-Traumatic Stress Injury Awareness Day in Louisiana.

3 WHEREAS, all citizens deserve the investment of every possible resource to ensure
4 their lasting physical, mental, and emotional well-being, and everyone is entitled to the
5 preservation of personal dignity; and

6 WHEREAS, post-traumatic stress is a significant public health issue that can result
7 from a variety of stressors including combat, interpersonal violence, high-impact collisions,
8 natural disasters, and exposure to the suffering of others; and

9 WHEREAS, post-traumatic stress has historically been unjustly portrayed as a
10 mental illness caused by a preexisting flaw of character or ability, and the word "disorder"
11 carries a stigma that perpetuates this misconception; and

12 WHEREAS, the diagnosis known as Post-Traumatic Stress Disorder (PTSD) was
13 initially formulated in 1980 by the American Psychiatric Association to describe and
14 categorize the symptoms and behavioral complications of severe traumatic stress; and

15 WHEREAS, the stigma presented by the term PTSD acts as a barrier that interferes
16 with seeking and receiving timely care; and

17 WHEREAS, electro-magnetic imaging has shown that severe traumatic stress causes
18 physical changes within the brain, which are more accurately described as an injury than a
19 disorder; and

20 WHEREAS, any injury exhibiting compliance with criteria A through H, §309.81
21 in the Diagnostic Statistical Manual deserves consideration and compensation strictly

1 matching legal entitlements provided for disabilities that have been or are currently,
2 classified as post-traumatic stress disorder; and

3 WHEREAS, timely access to appropriate treatment of traumatic stress injury can
4 avert complications and prevent suicide; and

5 WHEREAS, all citizens suffering from Post-traumatic Stress Injury deserve our
6 compassion and recognition, the brave men and women having received these wounds while
7 risking their lives to protect our freedom, safety, and welfare deserve special recognition for
8 their gallantry, commitment, and sacrifice.

9 THEREFORE, BE IT RESOLVED that the House of Representatives of the
10 Legislature of Louisiana does hereby designate June 27, 2024, as Post-Traumatic Stress
11 Injury Awareness Day in Louisiana and does hereby urge all citizens to observe this day and
12 month with appropriate ceremonies and activities that promote public understanding of the
13 challenges faced by individuals with traumatic stress injury and their families.
