LAW ENFORCE/OFFICERS: Requests a study of retention rates and salaries of police officers employed by the New Orleans Police Department

2	To the House Committee on Municipal, Parochial and Cultural Affairs to study retention
3	rates and salaries of police officers employed by the New Orleans Police Department
4	in comparison with police officers employed by similarly sized municipal police
5	departments in surrounding parishes and in other states and to report its findings to
6	the House of Representatives prior to the convening of the 2014 Regular Session of
7	the Legislature of Louisiana.
8	WHEREAS, the citizens in many areas of the state of Louisiana are enduring a spike
9	in violent, deadly crime as in New Orleans which is faced with one of the highest per capita
10	murder rates in the country; and
11	WHEREAS, members of the New Orleans Police Department provide a vital public
12	service by playing an essential role in safeguarding the rights and freedoms of the city's
13	citizens; and
14	WHEREAS, these brave individuals selflessly put themselves in harm's way to assure
15	the safety of the lives and property of the citizens of New Orleans; and
16	WHEREAS, due to expanding law enforcement responsibilities and decreasing
17	resources, maintaining a highly qualified and motivated police workforce has become one
18	of the greatest challenges facing law enforcement agencies today; and
19	WHEREAS, providing a competitive level of compensation is essential for the long-
20	term viability of the New Orleans Police Department as this will allow the department to
21	attract qualified people, get them to stay, and motivate them to higher levels of performance;

1 WHEREAS, the New Orleans Police Department and the United States Justice 2 Department are currently engaged in court proceedings regarding a consent decree which 3 will require the police department to overhaul its policies and procedures for use of force, 4 training, interrogations, searches and arrests, recruitment, and supervision; and 5 WHEREAS, it is imperative that the New Orleans Police Department employ and 6 retain highly qualified and motivated police officers as the city of New Orleans attracts 7 conventioneers and tourists from all over the world, and the city is a major driver of the 8 state's economy and the state's national reputation; and 9 WHEREAS, many similarly sized municipal police departments in surrounding 10 parishes and in other states are able to offer more competitive compensation packages to 11 their officers which in turn makes it more difficult for the New Orleans Police Department 12 to attract and retain highly qualified officers. 13 THEREFORE, the House of Representatives of the Legislature of Louisiana requests 14 the House Committee on Municipal, Parochial and Cultural Affairs to study retention rates 15 and salaries of police officers employed by the New Orleans Police Department in 16 comparison with police officers employed by similarly sized municipal police departments 17 in surrounding parishes and in other states and to report its findings to the House of 18 Representatives prior to the convening of the 2014 Regular Session of the Legislature of 19 Louisiana. 20 A copy of this Study Request shall be transmitted to the New Orleans City Council.
