MEDICAID. Provides for expansion of Medicaid coverage to include lymphedema treatment. (8/1/14)

AN ACT

2	To enact Chapter 8-B of Title 46 of the Louisiana Revised Statutes of 1950, to be comprised
3	of R.S. 46:980.1 through 980.3, relative to Medicaid coverage for the treatment of
4	lymphedema; to provide for coverage of treatment of lymphedema; to provide for
5	definitions; to provide for coverage of complete decongestive therapy (CDT)
6	supplies as components of treatment for lymphedema; to provide for coverage of the
7	cost of medically necessary compression supplies used in the treatment of
8	lymphedema; and to provide for related matters.
9	Be it enacted by the Legislature of Louisiana:
10	Section 1. Chapter 8-B of Title 46 of the Louisiana Revised Statutes of 1950,
11	comprised of R.S. 46:980.1 through 980.3, is hereby enacted to read as follows:
12	CHAPTER 8-B. MEDICAL ASSISTANCE PROGRAM COVERAGE FOR
13	LYMPHEDEMA TREATMENT AND MEDICALLY NECESSARY SUPPLIES
14	§980.1. Legislative findings
15	The legislature finds that:
16	(1) Lymphedema is a chronic, but treatable disease that results in an
17	accumulation of lymph fluid, causing swelling, in parts of the body where nodes

1	or lymphatic vessels are damaged or inadequate.
2	(2) Among several causes for lymphedema, the most common is damage
3	caused to the lymphatic system by cancer treatments.
4	(3) Despite the availability of largely successful treatments, if left
5	untreated lymphedema becomes progressive, leading to increased medical costs
6	and increased instances of morbidity.
7	(4) Without treatment lymphedema causes many patients to suffer from
8	recurrent infections, progressive deterioration in condition, generally, and
9	eventual disability and early death.
10	(5) The Centers for Medicare and Medicaid Services (CMS) does not
11	consider compression supplies used in lymphedema treatment to be "durable
12	medical equipment", and thus does not cover these supplies under Title XVIII
13	of the Social Security Act. Matching funds are not available through either
14	Medicare or Medicaid to cover the cost of treatment of lymphedema. Action by
15	the United States Congress is required to provide coverage for such treatment.
16	§980.2. Definitions.
17	For the purposes of this Chapter, the following terms shall have the
18	following meanings, unless the context clearly indicates otherwise:
19	(1) "Lymphedema" means the condition that is evidenced by swelling
20	in one's extremities caused by the blockage of nodes or lymphatic vessels that
21	have been damaged or rendered inadequate by cancer treatment.
22	(2) "Compression supplies" means to those garments or other items that
23	are necessary in the daily self-treatment and maintenance of the symptoms of
24	lymphedema, but fail to meet the definition of "durable medical equipment"
25	employed by the Centers for Medicare and Medicaid Services.
26	(3) "Medicaid" means the medical assistance program provided for in
27	Title XIX of the Social Security Act.
28	§980.3. Medicaid coverage
29	A. Should the United States Congress provide for coverage of the

treatment of lymphedema through the Medicaid program, the Department of
Health and Hospitals shall make all necessary state Medicaid plan amendments
to provide coverage for treatment of lymphedema, to include benefits for
equipment, compression supplies, complex decongestive therapy, gradient
compression garments and self-management, training and education, if the
treatment is determined to be medically necessary and is provided by a licensed
Medicaid provider.

B. Nothing in this Chapter shall be deemed to include disposable

B. Nothing in this Chapter shall be deemed to include disposable medical supplies, such as over-the-counter compression or elastic knee high or other stocking products not requiring a prescription.
