5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 37:1103(6) and (9) are hereby amended and reenacted and R.S.
7	37:1116(E) and (F) are hereby enacted to read as follows:
8	§1103. Definitions

10	(6) "Marriage and family therapy" means the professional application of
11	psychotherapeutic and family systems theories and techniques in the prevention,
12	diagnosis, assessment, and treatment of individuals, mental, emotional, and
13	behavioral disorders in an individual and relational disorders in couples, and
14	families.

16	(9) "Practice of marriage and family therapy" means the rendering of
17	professional marriage and family therapy and psychotherapy services, limited to
18	prevention, assessment, diagnosis, and treatment of mental, emotional,
19	behavioral, relational, and addiction disorders to individuals, couples, and
20	families, singly or in groups, whether such services are offered directly to the general
21	public or through either public or private organizations for a fee, monetary or
22	otherwise in accordance with professional training as prescribed by R.S. 37:1116
23	and code of ethics/behavior involving the application of principles, methods, or
24	procedures of the marriage and family therapy profession.

26	§1116. Licensure application for marriage and family therapists; temporary license

**SB NO. 121 ENROLLED** 1 or registration 2 3 E. Beginning January 1, 2018, a licensed marriage and family therapist who engages in the diagnosis of individuals shall furnish satisfactory evidence 4 to the board that he has completed the standard training in the professional 5 application of psychotherapeutic and family systems theories and a minimum 6 7 of six credit hours in diagnostic psychopathology, where students are taught to systematically collect and analyze data based on one or both of the two standard 8 9 diagnostic systems employed, International Classification of Diseases, current 10 revision, or the Diagnostic and Statistical Manual of Mental Disorders, current 11 edition. However, licensed marriage and family therapists who have satisfied 12 all other criteria for licensure as required by the board shall be allowed to 13 diagnose individuals upon demonstration of competency through continuing education or other measures as defined by the board. 14 15 F. Nothing in this Chapter shall be construed to authorize any person licensed under the provisions of this Chapter to assess, diagnose, or provide 16 treatment to any individual suffering from a serious mental illness, as defined 17 18 by R.S. 37:1103, when medication may be indicated, except when a licensed marriage and family therapist, in accordance with best practices, consults and 19 20 collaborates with a practitioner who holds a license or permit with the Louisiana State Board of Medical Examiners or an advanced practice registered 21 22 nurse licensed by the Louisiana State Board of Nursing who is certified as a 23 psychiatric nurse practitioner.
