CENSUS. Provides relative to provisions in Title 42 which are limited in applicability to political subdivisions or local areas meeting specified population characteristics.

2	To amend and reenact R.S. 42:15(B), 66(J), and 261(C), relative to the provisions of Title
3	42 (Public Officers and Employees) of the Louisiana Revised Statutes of 1950,
4	which are limited in applicability to certain political subdivisions or local areas based
5	upon population classifications; to specify applicability to one or more political
6	subdivisions or local areas; and to provide for related matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 42:15(B), 66(J), and 261(C) are hereby amended and reenacted to
9	read as follows:
10	§15. School board meetings; public comment

12	B. A school board in a parish containing a municipality with a population of
13	four hundred thousand or more according to the latest federal decennial census The
14	Orleans Parish School Board, at any meeting of the school board, shall provide an
15	opportunity for public comment subject to reasonable rules, regulations, and
16	restrictions as adopted by the school board.

3	J. Nothing in this Part shall be construed to prohibit an elected school board
4	member from holding employment as a juvenile probation officer in a district court,
5	as a parish prison warden, or as a deputy sheriff provided that such person, on
6	September 7, 1979, held elective office as a school board member and at the same
7	time held elective or appointive office in juvenile services of the district court, or
8	held elective office as a school board member and at the same time held employment
9	as a parish prison warden or as a deputy sheriff and has continued to so serve as a
10	school board member and in juvenile services of the district court, or as a school
11	board member and as a parish prison warden or a deputy sheriff. The provisions of
12	this Subsection relative to parish prison wardens and deputy sheriffs shall not be
13	applicable in any parish over 400,000 in population Orleans Parish, Jefferson
14	Parish, or East Baton Rouge Parish.

18	C. Notwithstanding the provisions of Subsections A and B of this section
19	Section or of any other law, the governing authority of any parish listed in the 1970
20	decennial federal census as having a total population of between 70,000 and 80,000
21	Terrebonne Parish may retain, select and/or or employ, on a full or part time full
22	or part-time basis or on retainer, an attorney to serve as its regular or special
23	attorney and in such case may fix and pay the salary or compensation of said
24	attorney. The employment of an attorney under this authorization relieves the
25	district attorney of responsibility.

<u>Proposed law</u>, contained in Title 42 (Public Officers and Employees) of the Louisiana Revised Statutes of 1950, legislates with regard to classifications of parishes, municipalities, or other political subdivisions or local areas according to population by limiting the application of laws based upon specific classifications to one or more parishes, municipalities, or other political subdivisions or local areas, as follows:
