2	To enact R.S. 40:1300.143(7)(a)(xiv), relative to rural hospitals; to provide with respect to
3	the definition of a rural hospital; to provide with respect to reimbursements and
4	payments; to provide for effective date and application; and to provide for related
5	matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 40:1300.143(7)(a)(xiv) is hereby enacted to read as follows:
8	§1300.143. Definitions
9	As used in this Part:
10	* * *
11	(7)(a) "Rural hospital" means a hospital licensed by the department which
12	meets one of the following criteria:
13	* * *
14	(xiv) Notwithstanding any law to the contrary, is a sole community
15	hospital under 42 CFR 412.92(a), and is located, according to the latest federal
16	decennial census, in a parish with a population of no less than fifty-three
17	thousand and no more than fifty-six thousand.

1	(aa) A rural hospital as defined in this Item shall maintain the same per
2	diem rates and shall not participate in the uncompensated care hospital
3	payments.
4	(bb) A rural hospital as defined in this Item shall fully participate in the
5	rural hospital upper payment limit program administered by the Department
6	of Health and Hospitals.
7	* * *
8	Section 2. This Act shall become effective July 1, 2013, subject to additional
9	appropriation by the legislature. Any hospital affected by this Act shall participate in the
10	rural hospital upper payment limit program administered by the Department of Health and
11	Hospitals only to the extent additional funds are available which exceed the amount of funds
12	appropriated for that program for fiscal year 2012-2013.

DIGEST

Allain (SB 170)

Proposed law includes within the definition of a rural hospital a sole community hospital under 42 CFR 412.92 which is located within a parish whose latest federal decennial census population is no less than 53,000 and no more than 56,000. Further, a rural hospital as defined in the <u>proposed law</u> shall maintain the same per diem rates and shall not participate in the uncompensated care hospital payments. A rural hospital as defined in the proposed <u>law</u> shall fully participate in the rural hospital upper payment limit program administered by the Department of Health and Hospitals.

Proposed law provides the effective date of the proposed law shall be July 1, 2013, subject to additional appropriation by the legislature. Any hospital affected by the proposed law shall participate in the rural hospital upper payment limit program administered by the Department of Health and Hospitals only to the extent additional funds are available which exceed the amount of funds appropriated for that program for fiscal year 2012-2013.

Effective July 1, 2013.
