2	To enact R.S. 47:337.11.2, relative to exemption from the sales and use taxes of political
3	subdivisions; to create the Acadiana Cultural and Entertainment Special District and
4	authorize certain parishes within the district to provide a certain exemption from
5	their sales and use taxes; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 47:337.11.2 is hereby enacted to read as follows:
8	§337.11.2. Acadiana Cultural and Entertainment Special District; optional
9	<u>exemption</u>
10	A. The Legislature of the State of Louisiana hereby finds that motion
11	picture production generated by Louisiana Motion Picture Investor Tax Credits
12	has been a benefit for the state. The 2011 Louisiana Entertainment Economic
13	Impact Analysis estimates that over the course of the three years covered in the
14	study motion picture productions will have spent approximately one billion five
15	hundred ten million dollars in Louisiana. To date, the typical production is
16	spending eighty percent of its budget in the state - and even blockbuster size
17	films with budgets in excess of twenty million dollars spend fifty percent, and
18	these percentages have steadily increased. From 2008 to 2010, productions
19	averaged ninety-two per year. However, the legislature also finds that,
20	unfortunately, the productions, and therefore their spin-off economic benefits,
21	have tended to be focused in certain regions of the state. Many areas have
22	received far less movie-making activity than others. Therefore, it is the
23	determination and intention of the legislature in enacting this Act to provide

1	another tax incentive tool to induce the location of movie picture production in
2	some of those heretofore neglected areas.
3	B. There is hereby created the Acadiana Cultural and Entertainment
4	Special District composed of all the parishes with the following populations
5	according to the latest federal decennial census:
6	(1) Any parish with a population between 50,000 and 52,250.
7	(2) Any parish with a population between 56,000 and 90,000.
8	(3) Any parish with a population between 200,000 and 230,000.
9	C. Any taxing authority within any parish in the ACES District may
10	provide for an exemption from their sales and use tax for the sales, purchases,
11	or leases and rentals by a motion picture production company for a specific
12	state-certified production by that company, all as set forth in the instrument,
13	resolution, vote, or other affirmative action providing the exemption. A separate
14	action providing an exemption shall be necessary for each state-certified
15	production granted the exemption.
16	D. For purposes of this Section, the following words and terms shall have
17	the following meanings:
18	(1) "ACES District" means the Acadiana Cultural and Entertainment
19	Special District.
20	(2) "Motion picture production company" shall have the same meaning
21	as provided for in R.S. 47:6007(B)(6).
22	(3) "State-certified production" means a production approved for
23	Louisiana Motion Picture Investor Tax Credits by the office of entertainment
24	industry development in the Department of Economic Development.
25	E. The exemption provided for in this Section shall not be granted on any
26	tax in effect on the date of the grant which secures bonds if the grant will affect
27	or impair the security of such bonds.
28	Section 2. This Act shall become effective upon signature by the governor or, if not
29	signed by the governor, upon expiration of the time for bills to become law without signature
30	by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If

vetoed by the governor and subsequently approved by the legislature, this Act shall become effective on the day following such approval.
