CRIME/PUNISHMENT. Provides for the crime of home invasion. (8/15/10)

AN ACT

2	To amend and reenact R.S. $14:62.8(B)(2)$ and to enact R.S. $14:2(B)(42)$, relative to the crime				
3	of home invasion; to provide for penalties at hard labor for under certain				
4	circumstances; and to provide for related matters.				
5	Be it enacted by the Legislature of Louisiana:				
6	Section 1. R.S. 14:62.8(B)(2) is hereby amended and reenacted and R.S. 14:2(B)(42				
7	is hereby enacted to read as follows:				
8	§2. Definitions

10	B. In this Code, "crime of violence" means an offense that has, as an element,				
11	the use, attempted use, or threatened use of physical force against the person or				
12	property of another, and that, by its very nature, involves a substantial risk that				
13	physical force against the person or property of another may be used in the course				
14	of committing the offense or an offense that involves the possession or use of a				
15	dangerous weapon. The following enumerated offenses and attempts to commit any				
16	of them are included as "crimes of violence":

6	(2) Whoever commits the crime of home invasion when, at the time of the				
7	unauthorized entering, there is present in the dwelling or structure any person who				
8	is under the age of twelve years, is sixty-five years of age or older, or who has a				
9	developmental disability as defined in R.S. 28:451.2, shall be fined not more than ten				
10	thousand dollars and shall be imprisoned at hard labor for not less than ten nor				
11	more than twenty-five years; at least ten years of the sentence imposed shall be				
12	served without benefit of parole, probation, or suspension of sentence.

DIGEST

<u>Present law</u> requires that whoever commits the crime of home invasion when, at the time of the unauthorized entering, there is present in the dwelling or structure any person who is under the age of twelve years, is 65 of age or older, or is developmental disabled, be fined not more than \$10,000 and be imprisoned for not less than ten nor more than 25 and requires that at least ten years of the sentence imposed shall be served without benefit of parole, probation, or suspension of sentence. <u>Proposed law</u> retains these provisions but requires that imprisonment be served at hard labor.

Proposed law includes home invasion as a crime of violence.

Effective August 15, 2010.
