SOLID WASTE. Provides relative to waste tires. (gov sig)

1 AN ACT

2 To amend and reenact R.S. 30:2418(I)(2), relative to waste tires; to provide for payments to
3 waste tire processing facilities for recycled waste tire material; to provide terms,
4 conditions, and requirements; and to provide for related matters.

5 Be it enacted by the Legislature of Louisiana:

6 Section 1. R.S. 30:2418(I)(2) is hereby amended and reenacted to read as follows:

7 §2418. Waste tires

8 * * *

9 I.(1) * * *

10 (2)(a) A permitted waste tire processing facility shall be paid ~~a minimum of~~
11 ~~seven and a half cents~~ **based on either** per pound of waste tire material that is
12 recycled or that reaches end market uses or per pound of whole waste tires that are
13 recycled or that reaches end market uses: **a minimum amount as follows:**

14 **(i) Nine and a half cents for processing waste tires that removes the steel**
15 **and tire cord and produces crumb rubber with a granular consistency.**

16 **(ii) Seven and half cents for processing waste tires that produces a**
17 **shredded rubber no larger than five inch by five inch.**

1 **(iii) Five and a half cents for processing waste tires to the minimum**
2 **required by R.S. 30:2412(31).**

3 **(b) This** ~~The~~ **payment provided for in this Paragraph** shall be made to the
4 facility on or before the twelfth day of the month following the submission of the
5 request for payment and shall be conditioned on the facility providing to the
6 department any documentation, including but not limited to manifests, statements,
7 or certified scale-weight tickets, required by law or by rules and regulations
8 promulgated by the department.

9 * * *

10 Section 2. This Act shall become effective upon signature by the governor or, if not
11 signed by the governor, upon expiration of the time for bills to become law without signature
12 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
13 vetoed by the governor and subsequently approved by the legislature, this Act shall become
14 effective on the day following such approval.

SB 423 Original 2016 Regular Session Walsworth

Present law provides that waste tire processing facilities will be paid a minimum of seven and a half cents per pound of waste tire material that is recycled or that reaches end market uses or per pound of whole waste tires that recycled or that reaches end market uses.

Proposed law changes the payment to waste tire processing facilities for waste tire material that is recycled to the following:

- (1) Nine and a half cents for processing waste tires that removes the steel and tire cord and produces crumb rubber with a granular consistency.
- (2) Seven and a half cents for processing waste tires that produces a shredded rubber no larger than five inch by five inch.
- (3) Five and a half cents for processing waste tires to the minimum requires by present law.

Effective upon signature of the governor or lapse of time for gubernatorial action.
