AN ACT

To amend and reenact R.S. 14:54.3(A), relative to the crime of manufacture and possession of a bomb; to provide relative to the definition of manufacture and possession of a bomb; to provide relative to licensing and regulation of explosives; and to provide for related matters.

Be it enacted by the Legislature of Louisiana:

Section 1. R.S. 14:54.3(A) is hereby amended and reenacted to read as follows:

§54.3. Manufacture and possession of a bomb

A. It shall be unlawful for any person without proper license as required by ~~R.S. 40:1471.1 et seq.~~ **R.S. 40:1472.1 et seq.**, knowingly and intentionally to manufacture, possess, or have under his control any bomb.

\* \* \*

Section 2. This Act shall become effective upon signature by the governor or, if not signed by the governor, upon expiration of the time for bills to become law without signature by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If vetoed by the governor and subsequently approved by the legislature, this Act shall become effective on the day following such approval.

DIGEST

Present law provides that it is unlawful for any person, without proper license as required by present law relative to the regulation of explosives, to knowingly and intentionally manufacture, possess, or have under his control any bomb.

Proposed law changes the present law reference to present law relative to the licensing and regulation of explosives to conform to present law numbering system.

Proposed law otherwise retains present law.

Effective upon signature of the governor or lapse of time for gubernatorial action.
