LSU SYSTEM. Provides for the Louisiana State University Health Services Center-New Orleans. (8/1/12)

1	AN ACT
2	To amend and reenact R.S. 17:1519.3, relative to the Louisiana State University Health
3	Sciences Center-New Orleans; to provide for certain hospitals and their operations;
4	and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 17:1519.3 is hereby amended and reenacted to read as follows:
7	§1519.3. Louisiana State University Health Sciences Center-New Orleans; health
8	care services division organization
9	A. The division and its component hospitals shall be under the immediate
10	direction and control of the LSU HSC-NO subject to the overall direction,
11	supervision, and management of the board.
12	B. No hospital nor any emergency room may be closed without legislative
13	approval. Such The approval may be granted by the legislature either by concurrent
14	resolution or by appropriate action in the General Appropriation Act.
15	C. The board or the division shall not authorize a hospital to reduce health
16	care services provided by any one of the hospitals of the Health Care Services
17	Division in any manner which causes expenditures of any hospital to be reduced on

1	an annualized basis by greater than thirty-five percent of the previous fiscal year
2	actual spending level. If any services are reduced by greater than fifteen percent in
3	any one year, legislative approval must be obtained before reducing such services
4	greater than fifteen percent in any year for the next three years. Funding may be
5	provided by any local, regional, state, federal, or private sources to augment existing
6	funding or to restore reduced funding.
7	D. In no event shall emergency medical treatment treatments be denied to
8	anyone in the nearest general hospital owned or operated by the board.
9	E. Louisiana State University Health Sciences Center-New Orleans shall
10	furnish to the Senate and House committees on health and welfare the same reports
11	that are prepared quarterly and submitted to the Joint Legislative Committee on the
12	Budget. Such The reports shall be submitted at the same time that they are made
13	available to the Joint Legislative Committee on the Budget.
14	F. Louisiana State University Health Sciences Center-New Orleans shall
15	furnish to the Senate and House committees on health and welfare the same reports
16	that are furnished to the Louisiana State University Board of Supervisors. Such The
17	report shall be submitted at the same time that they are made available to the Board
18	of Supervisors. Such The reports shall include but not be limited to a fiscal year
19	overview and any planned reductions at division hospitals.
20	G. Louisiana State University Health Sciences Center-New Orleans shall
21	furnish to the Senate and House committees on health and welfare quarterly reports,
22	individually by the hospital, on the length of time that patients wait for services
23	provided by the division hospitals.
