A CONCURRENT RESOLUTION

WHEREAS, it is appropriate to commend Danielle Lauren Borel upon her receipt of a 2012 Women of Excellence Award from the Louisiana Legislative Women's Caucus Foundation and to recognize her vital contributions to the citizens of Louisiana as an active and dedicated community servant; and

WHEREAS, Danielle was very active in several collegiate organizations including Chi Omega, Omicron Delta Kappa leadership society, Phi Kappa Phi honor society, and Phi Alpha Delta pre-law society; and

WHEREAS, she was elected by the student body to serve as the vice- president of LSU her junior year; working for the students, tackled issues of campus life, academics, and

WHEREAS, Danielle found time during her senior year to write a thesis for the Honors College, qualifying her to graduate with college honors, the highest level of recognition given by the Honors College with her thesis, "Multiparty Negotiations and Their Settings: How a Change in Location Can Change Bargaining Strategies", taking an indepth look at how settings can affect the outcomes of multiparty negotiations; and

WHEREAS, she was selected for the 2010-2011 LSU Homecoming Court; and

WHEREAS, Danielle was selected by the faculty as a Rucks Fellows which represents the highest level of academic achievement among senior management majors; and

WHEREAS, during the 2011 legislative session, Danielle worked with the Legislators Charity Fund to organize HoopLA, an annual House versus Senate basketball game that raises money to refurbish basketball courts across the state and with her as the event coordinator, the organization hosted its first event for the homeless community of Baton Rouge and they provided homeless individuals with brand new backpacks filled with supplies to help make life on the streets easier, feed them lunch, and had medical staff present to perform blood pressure checks; and

WHEREAS, she is currently studying at the LSU Paul M. Hebert Law Center and expects to graduate in May 2014; in her first semester of law school, she was elected as class president and organized events to help the students adjust to the atmosphere and workload; and currently, Danielle is in the top ten percent of her class; and

WHEREAS, the Louisiana Legislative Women's Caucus Foundation created the Women of Excellence Awards to recognize and honor extraordinary women of excellence across the state for their outstanding achievements and contributions; and
