COMMENDATIONS. Commends and congratulates Chanda Rubin for being named to the 2013 Louisiana Sports Hall of Fame Induction Class.

1	A RESOLUTION
2	To commend Chanda Rubin on being named to the 2013 Louisiana Sports Hall of Fame
3	Induction Class.
4	WHEREAS, each year Louisiana's sports writers select a limited number of athletes,
5	past or present, who have become figures of national and international renown to be
6	regarded as the state's immortals in the sphere of athletes and enshrined in the Louisiana
7	Sports Hall of Fame; and
8	WHEREAS, the 2013 Louisiana Sports Hall of Fame Class includes Lafayette native
9	and tennis star Chanda Rubin; and
10	WHEREAS, Ms. Rubin began playing tennis at age five and competed in her first
11	tournament at age seven, and in 1988, at the tender age of eleven, she won the United States
12	Tennis Association's Junior National Championship Girls' Division, age 12 and under; and
13	WHEREAS, in 1989, Ms. Rubin won her second USTA Junior National
14	Championship, this time in the Girls' Division age 14 and under, and a short two years later,
15	was chosen for the national team by the USTA, the youngest player ever to be selected; and
16	WHEREAS, in 1992, at age fifteen, Ms. Rubin won the Wimbledon Girls' Singles
17	Championship, a major win, and turned pro that same year; and
18	WHEREAS, over the next thirteen years, Ms. Rubin became an international star and

1	a frequent contender for the most prized titles in women's tennis, highlighted by capturing
2	a Grand Slam win in doubles at the 1996 Australian Open with Arantxa Sanchez-Vicario;
3	and
4	WHEREAS, Ms. Rubin reached a career high ranking of sixth in the world, reached
5	the fourth round or better in all four Grand Slam tournaments, and won seven Women's
6	Tennis Association singles titles, ten WTA doubles titles and two International Tennis
7	Association titles; and
8	WHEREAS, in 1997, Ms. Rubin teamed up with Justin Gimelstob to win the
9	Hopman Cup, first ever win for the United States, and she was also a member of the U.S.
10	Fed Cup team from 1995-1997 and 1999-2004, the U.S. Olympic Team in 1996 and 2004,
11	and the U.S. Pan-American Team in 1995, where she won silver and bronze medals; and
12	WHEREAS, in addition to her exciting wins, Ms. Rubin has also been the recipient
13	of numerous awards including: 1995 American Tennis Association Athlete of the Year; 1996
14	USTA Female Athlete of the Year; 1996 US Olympic Committee Female Athlete of the
15	Month, and thereafter Female Athlete of the Year; 1995 WTA's Most Improved Player
16	Award; 1997 Arthur Ashe Leadership Award; 1998 USA Magazine's Most Caring Athlete
17	Award; 2002 Hormel Foods/Family Circle Player Who Makes a Difference Award; 2003
18	USTA Service Bowl Award; 2008 Gene Scott Renaissance Award; 2008 International Lawn
19	Tennis Danzig Trophy; and 2009 Southern Tennis Hall of Fame Inductee; and
20	WHEREAS, Chanda Rubin truly possesses the character, skills and talents worthy
21	of being named to the Louisiana Sports Hall of Fame.
22	THEREFORE, BE IT RESOLVED that the Senate of the Legislature of Louisiana
23	does hereby commend and congratulate Chanda Rubin on being named to the 2013
24	Louisiana Sports Hall of Fame Induction Class.
