RESOLVE Resolve Special commission independent auto repair industry

Resolved,

1 RESOLVE PROVIDING FOR AN INVESTIGATION AND STUDY BY A SPECIAL

2 COMMISSION RELATIVE TO THE INDEPENDENT AUTO REPAIR INDUSTRY.

3 Resolved, That a special commission to consist of: 2 members of the senate, 1 of whom shall be

- 4 appointed by the Senate President, 1 by the Senate Minority Leader, 2 members from the House
- 5 of Representatives, 1 of whom shall be appointed by the Speaker of the House, 1 by the House
- 6 Minority Leader, the Attorney General or her designee, and 10 persons to be appointed by the
- 7 Governor, 2 of whom shall be representatives of the New England Service Station and
- 8 Automotive Association, 2 of whom shall be members of the Massachusetts Auto Dealers
- 9 Association, 2 of whom shall be representatives of the Auto Manufacturers, 2 of whom shall be
- 10 representatives of automotive aftermarket parts and tool manufacturing associations, 1 of whom
- 11 shall be a representative of a consumer advocacy organization, 1 of whom shall be a
- 12 representative of a small business organization; is hereby established for the purpose of making

- 13 an investigation and study relative to the ability of independent auto repair businesses to repair
- 14 automobiles after the expiration of any warranty. The commission's investigation shall include,
- 15 but not be limited to: determining, whether independent repair businesses have the ability and
- 16 means to obtain necessary tools and information to repair automobiles and receive proper
- 17 education in the repair of such vehicles.
- 18 Said commission shall report to the general court the results of its investigation and study, and its
- 19 recommendations, if any, together with drafts of legislation necessary to carry its
- 20 recommendations into effect by filing the same with the clerks of the house of representatives
- 21 and senate who shall forward the same to the joint committee as determined by the house and
- 22 senate on or before January 31, 2012.
