An Act authorizing deer hunting on Sunday.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Section 57 of chapter 131 of the General Laws, as appearing in the 2010
- 2 Official Edition, is hereby amended by inserting after the word “mammal”, in line 3, the
- 3 following words:- with the exception of deer during open deer hunting season.
