## The Commonwealth of Massachusetts

In the Year Two Thousand Thirteen

An Act to encourage quality reviews and reduce costs in health care.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section (1)

2 Chapter 111 of the General Laws, as appearing in the 2012 Official Edition, is hereby amended by inserting at the end of section 204 the following:

4 (f) The provisions of this section shall apply to any committee formed by an individual 5 health care provider, physician group practice, licensed health care facility or any combination 6 thereof to perform the duties or functions of medical peer review as set forth in section one of this chapter, notwithstanding the fact that the formation of the committee is not required by law or regulation or that the individual, group or facility is not solely affiliated with a public hospital or licensed hospital or nursing home or health maintenance organization.

Chapter 231: Section 60K of the General Laws as appearing in the 2012 Official Edition 11 12 is

13 hereby amended by its deletion and replacement with the following:

Section 60K. In any action for malpractice, negligence, error, omission, mistake or 15 unauthorized rendering of professional services against a provider of health care, in which a verdict is rendered or a finding made or an order for judgment made for pecuniary damages for

personal injuries to the plaintiff or for consequential damages, there shall be added by the clerk

18 of the court to the amount of damages interest thereon, at a rate to be determined as set forth

19 below rather than the rate specified in section 6B of chapter 231, from the date of the
