- 33 (b) The initial data report shall include all prior Independent Testing Laboratory data 34 submitted to the Commission. The initial report shall be published per Independent Testing 35 Laboratory per quarter inclusive of reports. Subsequent data reports shall be updated and 36 published on a quarterly basis detailing information from the preceding quarter.
 - (c) The Commission shall investigate and publicly report the reason for the discrepancy for individual Independent Testing Laboratories that are statistically significant outliers in terms of their testing results.
- 40 (d) The Commission shall promulgate regulations in accordance with this section no 41 later than one year after the effective date of this act.
