An Act relative to the use of crossbows.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 An Act Relative to the Use of Crossbows
- 2 SECTION 1. Section 64 of Chapter 131 is hereby amended by deleting it in its entirety and
- 3 replacing it with the following:-
- 4 Chapter 131, Section 64. A person shall not use for hunting purposes any type of full automatic
- 5 firearm, machine gun or submachine gun, nor use any tracer or incendiary ammunition for
- 6 hunting or outdoor target shooting purposes except on a skeet, trap, or target range.
- 7 SECTION 2. Section 64 of Chapter 131 is hereby amended by deleting it in its entirety and
- 8 replacing it with the following:-
- 9 Chapter 131, Section 69. A person shall not carry or use a bow and arrow or crossbow while
- 10 hunting unless said bow and arrow or crossbow meet such requirements as may be set by rules

- 11 and regulations which the director is hereby authorized to promulgate. Such rules and regulations
- 12 shall prescribe general design, weight of pull, and type of bows and arrows or crossbows, and
- 13 shall conform to standards generally accepted for hunting purposes.
