The Commonwealth of Massachusetts

**In the One Hundred and Ninety-Second General Court
(2021-2022)**

An Act improving access to affordable higher education.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. The department of higher education shall review programs of financial aid
2 for students attending public institutions of higher education in the commonwealth, including
3 grants, tuition waivers and loan programs. Based on the review, the department shall make
4 recommendations, including legislation, for comprehensive redesign and reform of the financial
5 aid system to increase student access to higher education, improve affordability of higher
6 education for students and families, and reduce opportunity and achievement gaps among
7 students, particularly for students of color and disadvantaged populations.

8 The goals of the financial aid redesign and reform shall include:

9 (1) consolidating multiple overlapping assistance programs to improve efficiency and
10 reduce duplication;

11 (2) reducing the burden of the application process and improving transparency,
12 predictability and the ease of navigation for students and their families applying for and
13 renewing financial assistance;

14 (3) lessening administrative costs, including the costs of oversight; and

15 (4) strengthening the ability of the general court to appropriately monitor, oversee and
16 appropriate funds provided for student financial assistance.

17 In preparing its recommendations, the department shall consult with institutional
18 financial aid officers, the office of student financial assistance and its financial aid advisory
19 committee, groups representing students at the University of Massachusetts, state universities
20 and community colleges, students and parents who navigate and use state financial aid, and other
21 stakeholders. The department shall review the design of financial aid programs in other states
22 and recommendations of experts. The department shall also solicit information from the chairs
23 and vice chairs of the committee on higher education.

24 Before releasing its recommendations, the department shall hold an open public listening
25 session to receive public input.

26 The department shall file its findings, recommendations and accompanying legislation, if
27 any, with the clerks of the house of representatives and the senate and the joint committee on
28 higher education not later than December 31, 2021.

29 SECTION 2. The department of higher education shall explore the feasibility of and
30 prepare a plan for all graduates of high schools in the commonwealth to have available to them

31 (1) a free application process for public institutions of higher education, and

32 (2) automatic admission to a public community college.

33 In preparing the plan, the department shall consult with administrative officials at
34 institutions of higher education, including admissions officers; groups representing students and
35 parents; high school college counselors and other stakeholders. The department shall also consult
36 with experts in higher education and expanding student opportunities. The department shall also
37 solicit information from the chairs and vice chairs of the committee on higher education.

38 Before releasing its recommendations, the department shall hold an open public listening
39 session to receive public input.

40 The department shall file its findings, recommendations and accompanying legislation, if
41 any, with the clerks of the house of representatives and the senate and the joint committee on
42 higher education not later than December 31, 2021.
