In the One Hundred and Ninetieth General Court (2017-2018)

An Act to provide diabetes prevention program benefits.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Chapter 32A of the General Laws, as appearing in the 2014 Official
- 2 Edition, is hereby amended by inserting after section 17O the following section:-
- 3 Section 17P. The commission shall provide to any active or retired employee of the
- 4 commonwealth who is insured under the group insurance commission and is identified as
- 5 someone with prediabetes those items and services furnished under a diabetes prevention
- 6 program recognized as a National Diabetes Prevention Program as established by the federal
- 7 Centers for Disease Control and Prevention.
