AN ACT REQUIRING THE DISCLOSURE OF OBSCENE MATERIALS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Section 29B of chapter 272 of the General Laws, as appearing in the 2004 Official Edition,
- 2 is hereby amended by adding the following subsection:-
- 3 (f) Any commercial film and photographic print processor or computer technician who has knowledge of
- 4 or observes, within the scope of such person's professional capacity or employment, any film,
- 5 photograph, video tape, negative, or slide, or any computer file, recording, cd-rom, magnetic disk
- 6 memory, magnetic tape memory, picture, graphic, or image that is intentionally saved, transmitted or
- 7 organized on hardware or any other means and whether directly viewable, compressed or encoded, that he
- 8 reasonably believes to be depicting a real child under the age of 18 engaged in an act of sexual conduct,
- 9 sexual performance, or in a sexually explicit posture, shall immediately or as soon as reasonably
- 10 possible, report such instance of suspected child abuse or child pornography to the local police and shall
- prepare and send a written report of the incident with an attached copy of such material, if possible,
- within 36 hours after receiving the information concerning the incident.
- 13 The following shall apply:
- 14 (i) the identity of the computer technician shall be confidential, subject to disclosure only with his consent
- or by judicial process; and
- 16 (ii) provided the computer technician has acted in good faith, he shall be immune from civil liability that
- might otherwise be incurred by his actions. This immunity extends only to acts described in this
- 18 subsection.
- 19 For purposes of this subsection "commercial film and photographic print processor" shall mean any
- 20 person who develops exposed photographic film into negatives, slides, or prints, or who makes prints
- 21 from negatives or slides, for compensation. This term shall also include any employee or agent of such a

- 22 person but shall not include a person who develops film or makes prints for a public agency; and
- 23 "commercial computer technician" shall mean any person who repairs, installs, or otherwise services any
- 24 digital storage media including, but not limited to, any component part, device, memory storage or
- 25 recording mechanism, auxiliary storage, recording or memory capacity, or any other materials relating to
- operation and maintenance of a computer or computer network or system, for compensation. The term
- shall also include any employee or agent of such person.
- Any person who violates the provisions of this section, upon conviction, shall be punished by a fine not to
- 29 exceed \$1000 or by imprisonment not to exceed one year, or both such fine and imprisonment.
- Nothing in this section shall be construed to require or authorize any person to act outside the scope of
- 31 such person's professional capacity or employment by searching for prohibited materials or media.
