An Act expanding credible service to certain veterans.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Subdivision (1) of section 4 of chapter 32 of the General Laws as appearing  
2 in the 2012 Official Edition is hereby amended by inserting after subsection (r), the following  
3 subsection:-

4 (r ½) Notwithstanding any general or special law to the contrary, a member in service of  
5 a retirement system as defined in section 1 who served in the Commissioned Corps of the United  
6 States Public Health Service or the Commissioned Corps of the National Oceanic and  
7 Atmospheric Administration and who has completed 4 or more years of membership service,  
8 and who retires on or after January 1st 1975 shall receive full credit for the period of such  
9 commissioned corps service. Eligibility for the creditable service of members in service of a  
10 retirement system shall be conditioned upon payment, in 1 sum or in installments upon such  
11 terms as the applicable retirement board may provide, into the annuity savings fund of the  
12 applicable retirement system, of an amount equal to the contributions such member in service

13 would have otherwise paid into the retirement system plus buyback interest thereon for the  
14 period of commissioned corps service based upon the annual salary the member received in the  
15 first year of membership service after his or her commissioned corps service.
