An Act relative to parole hearings for previous life sentences.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 24 of Chapter 279 of the General Laws, as appearing in the 2016  
2 Official Edition, is hereby amended in line 19 by striking out the following: “20” and inserting in  
3 place thereof the following: “30”.

4 SECTION 2. Section 24 of Chapter 279 of the General Laws, as appearing in the 2016  
5 Official Edition, is hereby amended in line 20 by striking out the following: “30” and inserting in  
6 place thereof the following: “40”.

7 SECTION 3. Section 24 of Chapter 279 of the General Laws, as appearing in the 2016  
8 Official Edition, is hereby amended in line 24 by striking out the following: “30” and inserting in  
9 place thereof the following: “40”.

10 SECTION 4. Section 24 of Chapter 279 of the General Laws, as appearing in the 2016  
11 Official Edition, is hereby amended in line 29 by striking out the following: “25 years nor more  
12 than 30” and inserting in place thereof the following: “35 years nor more than 40”.
