The Commonwealth of Massachusetts

In the Year Two Thousand Eleven

An Act to reduce the cost of outpatient care.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Section 1.
- 2 Section 25B of Chapter 111 of the Mass General Laws, as appearing in the 2008 official edition,
- 3 is hereby amended in the definition of "Substantial Change of Services", by striking the last

4 sentence.

- 5 Section 2.
- 6 Section 25C of Chapter 111, is hereby amended in the sixth paragraph, by adding at the end
- 7 thereof the following:
- 8 Any acute care hospital seeking to build or expand an outpatient surgical or diagnostic facility
- 9 shall a determination of need with the department. In determinations on applications for new
- 10 outpatient surgical or diagnostic facilities or for substantial changes in services for licensed

outpatient diagnostic or surgical facilities, the department shall apply the same criteria for thoseowned by acute care hospitals and freestanding ambulatory surgery centers.

13 Section 3.

14 Section 25C of Chapter 111, is hereby amended by adding at the end thereof the following new15 paragraph:

The Department shall conduct a statewide planning initiative for the purposes of studying and 16 coordinating the availability and delivery of outpatient diagnostic and surgical health care 17 services within the commonwealth. The initiative shall examine the current supply of outpatient 18 19 services, and technologies and develop a plan for the provision of new services, technologies, and structural expansions throughout the commonwealth, and develop a plan for the continued 20 role of freestanding ambulatory surgery centers within the commonwealth. The Department 21 22 shall utilize this plan in its evaluation of all applications for a determination of need, as required by this section, in order to determine whether the proposed expansion construction, or 23 acquisition of health care facilities or services is needed in the Commonwealth, or whether the 24 proposed expansion construction, or acquisition of health care facilities or services will 25 unnecessary duplicate ongoing services and increase health care costs in the Commonwealth." 26 Section 4. 27

28 Section 1 of Chapter 118G, is hereby amended in definition of "ambulatory surgical center" by29 adding at the end thereof the following:

- 30 A single specialty or multi-specialty ambulatory surgical center which is licensed under the
- 31 provisions of Chapter 111 shall be included herein and shall be qualified for full participation in
- 32 the Medicaid program.
