RESOLVE Resolve providing for an investigation and study by a special commission relative to reducing the wait time for medical equipment for children with special health care needs

Resolved,

- 1 Resolved, There shall be a commission to investigate and study the process by which children
- 2 with special health care needs are provided durable medical equipment including, but not limited
- 3 to, wheelchairs and lifts and to make recommendations relative to reducing barriers that such
- 4 children and their families experience in procuring medically necessary and physician-prescribed
- 5 equipment in a timely manner. The commission shall be known as "the commission to reduce
- 6 wait time for children with special health care needs to receive needed medical equipment". The
- 7 commission shall be chaired by the commissioner of public health and the commissioner of the
- 8 division of medical assistance and shall consist of the president of the senate or a designee
- 9 thereof, the minority leader of the senate or a designee thereof, the speaker of the house of
- 10 representatives or a designee thereof, the minority leader of the house of representatives or a
- 11 designee thereof, the house and senate chairpersons of the joint committee on health care
- 12 financing or their designees, a parent of a child with special health care needs who shall be
- 13 appointed by the governor, a licensed physician who treats children with special health care

- 14 needs who shall be appointed by the governor, a designee of Children's Hospital Boston, a
- 15 designee of the Disability Law Center and a designee of the Massachusetts Association of Health
- 16 Plans.
- 17 The commission shall make recommendations for fair and suitable guidelines for private health
- 18 insurers, the state Medicaid program and vendors to promptly process prescriptions for durable
- 19 medical equipment for children with special health care needs.
- 20 The commission shall report its findings to the clerk of the senate, the clerk of the house of
- 21 representatives and the house and senate committees on ways and means not later than December
- 22 31, 2012.
