AN ACT ESTABLISHING AN AUTISM COMMISSION.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. There shall be a special commission to investigate and study services and supports for
- 2 individuals with autistic spectrum disorders, which shall include, but not be limited to, Asperger's
- 3 syndrome, high functioning autism, and pervasive development disorder not otherwise specified and who
- 4 do not therefore have a condition that meets the definition of mental retardation as defined in 1992 by the
- 5 American association of mental retardation. The commission shall consist of: a member of the house of
- 6 representatives, appointed by the speaker of the house of representatives and a member of the senate
- 7 appointed by the president of the senate, a member of the house of representatives appointed by the
- 8 minority leader of the house of representatives and a member of the senate appointed by the minority
- 9 leader of the senate, a representative of the governor; the secretary of the executive office of health and
- human services or the secretary's designee; the commissioner of the department of mental retardation, or
- the commissioner's designee; the commissioner of the department of mental health, or the commissioner's
- designee; the commissioner of the department of education, or the commissioner's designee; 8 of whom
- shall be named by the Statewide Autism group; 2 of whom shall be named by the Asperger's Association
- 14 of New England; and 2 of whom shall be named by the Autism Society of America, Massachusetts
