By Mr. Roy of Franklin, a petition (accompanied by bill, House, No. 1859) of Jeffrey N. Roy and others relative to transmitting indecent visual depictions by teens. The Judiciary.

**In the One Hundred and Ninety-Second General Court
(2021-2022)**

An Act relative to transmitting indecent visual depictions by teens.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1: Chapter 272 of the General Laws is hereby amended by inserting after
2 section 29C the following section:-

3 Section 29D.

4 (a) Whoever, while under 18 years of age, possesses or disseminates to another person
5 any visual material, including but not limited to, a photograph, media, or a text message with
6 attached media, that violates sections 29B or 29C of this chapter or whoever, while under 18
7 years of age, intentionally obtains material in violation of this section and distributes the material
8 by means of uploading same on an Internet website, shall be punished by a fine of not less than
9 fifty nor more than five hundred dollars or by commitment to the department of youth services
10 for not more than six months, or both.

11 (b) A person does not knowingly disseminate the material in violation of this section by
12 reporting the matter to a law enforcement agency, teacher, principal, or parent, or by affording a
13 law enforcement agency, teacher, principal, or parent access to the material.

14 (d) A person who has been adjudicated under this section shall not be required to
15 register with the Sex Offender Registry Board and no data relating to such adjudication shall be
16 transmitted to the Board pursuant to G.L. c. 6, § 178E.

17 (e) The juvenile court department shall have exclusive jurisdiction of proceedings under
18 this section.

19 (f) It shall be an affirmative defense for any crime alleged under G.L. c. 272, §§ 29A,
20 29B, 29C, or 29D that (a) the visual material portrays no person other than the defendant; or (b)
21 the defendant was under 18 years of age, the material portrays only an individual over the age of
22 15 and was knowingly and voluntarily created and provided to the defendant by the individual in
23 the image, and the defendant has not provided or made available the material to another person
24 except the individual depicted who originally sent the material to the defendant.

25 (g) Nothing in this section shall be construed to prohibit a prosecution for disorderly
26 conduct, public indecency, child pornography, or any other applicable provision of law.

27 SECTION 2. Chapter 119 of the General Laws is hereby amended by inserting after
28 section 39L the following section:-

29 Section 39M. If a child is alleged to be a juvenile delinquent by reason of violating
30 sections 29B, 29C, or 29D of this chapter, unless the district attorney objects in writing stating
31 the reasons for the objection, the court shall, if arraignment has not yet occurred, indefinitely stay

32 arraignment and direct that the child enter and complete an educational diversion program
33 approved by the district attorney. If the court finds, on its own motion or at the request of the
34 prosecutor, that the child has failed to complete the diversion program, the court shall bring the
35 case forward, arraign the child and restore the delinquency complaint to the docket for further
36 proceedings. If arraignment has already occurred, unless the district attorney objects in writing
37 stating the reasons for the objection, the court shall place the child on pretrial probation under
38 section 87 of chapter 276. The conditions of such probation shall include, but not be limited to,
39 completion of an educational diversion program approved by the district attorney or attorney
40 general. If the child fails to comply with the conditions of probation, the court shall restore the
41 delinquency to the docket for trial or further proceedings.

42 The Attorney General, in consultation with the Massachusetts Aggression Reduction
43 Center (MARC) at Bridgewater State University and the Department of Elementary and
44 Secondary Education, shall develop and create a comprehensive educational diversion program
45 designed to provide teenagers with information about the legal consequences of and penalties for
46 transmitting indecent visual depictions known as “sexting” or posting indecent visual depictions
47 online, including the applicable federal and state statutes; the non-legal consequences of sexting
48 or posting such pictures, including, but not limited to, the effect on relationships, loss of
49 educational and employment opportunities, and being barred or removed from school programs
50 and extracurricular activities; how the unique characteristics of cyberspace and the Internet can
51 produce long-term and unforeseen consequences for sexting and posting such photographs; and
52 the connection between bullying and cyber-bullying and juveniles sexting or posting sexual
53 images. The educational diversion program shall be used as part of any diversion program
54 required in this section and shall be made available to school districts for use in educational

55 programs on the topic. The Department of Elementary and Secondary Education shall encourage
56 school districts to implement instruction in media literacy skills at all grade levels, and in any of
57 the core subjects or other subjects, to equip students with the knowledge and skills for accessing,
58 analyzing, evaluating, and creating all types of media.
