By Ms. Haddad of Somerset, a petition (accompanied by bill, House, No. 2057) of Wolf and Haddad relative to the rate of insurance reimbursement for certain services provided by physician assistants Joint Committee on Financial Services.

The Commonwealth of Massachusetts

In the Year Two Thousand Eleven

An Act relative to physician services provided by physician assistants.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Chapter 175 of the General Laws is hereby amended by inserting after section 47U,
2 inserted by section 8 of chapter 141 of the acts of 2000, the following section:-
3 Section 47V. No individual or group accident and health insurance policies and health service
4 contracts can refuse to reimburse a physician at the full rate for necessary medical or surgical
5 services provided by a physician assistant practicing under the supervision of a physician if the
6 policy or contract would have paid for the same services when provided by a physician.
7 Individual or group accident and health insurance policies and health service contracts cannot
8 impose a practice or supervision restriction which is inconsistent or more restrictive than state
9 law. Provided, however, that the following conditions are met:(1) the service rendered is within
10 the scope of practice of physician assistants pursuant to section 9E of said chapter 112; (2) such
11 service is provided in compliance with all other requirements of law, including a formal

12 supervisory arrangement with a physician as provided for by said section 9E (3) the policy or
13 contract provides benefits for such service if rendered by a registered physician in the
14 commonwealth

15 SECTION 2. Chapter 176A of the General Laws is hereby amended by inserting after SECTION
16 8Z, the following section:-

17 Section 8V. No contract or subscription certificate between an insured and the corporation can
18 refuse to reimburse a physician at the full rate for necessary medical or surgical services
19 provided by a physician assistant, certified by the board of registration of physician assistants
20 pursuant to the provisions of section 9F of chapter 112, practicing under the supervision of a
21 physician if the contract or subscription certificate would have paid for the same services when
22 provided by a physician. A contract or subscription certificate between an insured and the
23 corporation cannot impose a practice or supervision restriction which is inconsistent or more
24 restrictive than state law; provided, however, that the following conditions are met: (1) the
25 service rendered is within the scope of practice of physician assistants pursuant to section 9E of
26 said chapter 112; (2) such service is provided in compliance with all other requirements of law,
27 including a formal supervisory arrangement with a physician as provided for by said section 9E;
28 and (3) the contract or subscription certificate provided benefits for such service if rendered by a
29 registered physician in the commonwealth.

30 SECTION 3. Chapter 176B of the General Laws is hereby amended by inserting after SECTION
31 4U, inserted by section 4R the following section:-

32 Section 4V. No contract or subscription certificate between an insured and the corporation can
33 refuse to reimburse a physician at the full rate for necessary medical or surgical services

34 provided by a physician assistant, certified by the board of registration of physician assistants
35 pursuant to the provisions of section 9F of chapter 112, practicing under the supervision of a
36 physician if the contract or subscription certificate would have paid for the same services when
37 provided by a physician. A contract or subscription certificate between an insured and the
38 corporation cannot impose a practice or supervision restriction which is inconsistent or more
39 restrictive than state law; provided, however, that the following conditions are met: (1) the
40 service rendered is within the scope of practice of physician assistants pursuant to section 9E of
41 said chapter 112; (2) such service is provided in compliance with all other requirements of law,
42 including a formal supervisory arrangement with a physician as provided for by said section 9E;
43 and (3) the contract or subscription certificate provides benefits for such service if rendered by a
44 registered physician in the commonwealth. No such contract or subscription certificate shall
45 deny payment for such services solely on the basis that the service was provided by a physician
46 assistant.

47 SECTION 4. The first paragraph of section 4 of chapter 176G of the General Laws is hereby
48 amended by adding the following sentence:-

49 Such health maintenance contract shall also provide coverage for the services rendered by a
50 certified registered physician assistant, as set forth in section 47V of chapter 175, subject to the
51 provisions of said section.
