An Act relative to furthering community preservation..

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 7 of chapter 44B of the General Laws, as appearing in the 2008 Official
2 Edition, is hereby amended by striking, in line 11, the word “and”, and inserting after the words
3 “Preservation Fund” in line 13, the following new words:-

4 “; and (d) all funds received from public and private sources as gifts, grants, and donations to
5 further community preservation.”.

6 SECTION 2. Section 10 of said chapter 44B, is hereby amended by adding, in line 9, after the
7 word “applied” the following new words:-

8 “, as well as the amount the municipality has raised through public and private gifts, grants, and
9 donations”.

10 SECTION 3. Section 10 of said chapter 44B, is hereby amended by adding, in line 16, after the
11 word “town” the following new words:-

- 12 “plus the total amount of public and private gifts, grants, and donations to the community
- 13 preservation fund”.
